Ingredients: Prunus armeniaca (Apricot Kernel oil), Simmondsia chinesis (Jojoba oil), Rosa canina (Rosehip oil), Calendula officinalis (Calendula macerated oil), Oenthera biennis (Evening Primrose oil), Tocopheryl acetate (Vitamin E) and essential oils (0.9%) Pelargonium Roseum (Rose Geranium), Boswellia carterii (Frankincense), Pogostemon cablin Blanco (Patchouli), Cymbopogon martinii (Palmarosa) & Lavandula angustifolia (Lavender), *Geraniol, *alpha-Pinene, *Occurs naturally in essential oils. Allergens listed in bold. CONTAINS APRICOT KERNEL OIL.

Storage instructions: Store in a cool, dark place, **out of direct sunlight. Keep out of reach of children and pets.** Store in original container. Refrigerate if possible, as this will keep your blend fresher for longer. **Discard after expiry date.**

Instructions for use: Shake well before use. Warm a few drops of oil in the palms of your hands and massage onto the face and neck avoiding the eye area, allow oil to absorb for a couple of minutes before applying moisturiser.
