Mr. Sengstock...please accept this correspondence as the City's response to your request for disclosure of the names of children employed by the City of Twinsburg.

The City determined that it was in the best interests of the children to not release their names as part of a public records request made by you. Although the Sunshine Law does not specifically prohibit the release of children's names from a records request, the decision was made to hold the privacy of children to a higher standard as compared to the adult employees. Some of our part-time and seasonal employees are as young as 16 years old. We believe that it is prudent to protect their identity from potential harm that could come to them by publishing their names and positions with the City.

Your request was for the "payroll registry" and you were provided that document. The City provided you documentation of the number of employees, the wages they earned and the department that they served. Disclosure of the **names of minors** that worked at the outdoor waterpark or summer day camp does not further any public interest in your desire to ensure governmental accountability. Furthermore, the City has an obligation to our minor employees and their parents to protect their children's personal identifiers. Disclosure of personal information of children creates an unnecessary risk of harm to them that does not serve the purpose of the Sunshine Law.

If you disagree with the City's position in this regard you can certainly pursue redress through the courts.

My complaint is that the City of Twinsburg has redacted information such as minor employee name and various deductions which the City has no legal authority to redact. The report does not contain birth dates, social security numbers, or even addresses; however, it is my contention that the public has a right to this information for transparency and accountability of our tax dollars. The reports obtained are being used for public information on the Active Citizens of Twinsburg website (https://activecitizensoftwinsburg.com/) to provide a public source for Twinsburg citizens as the City of Twinsburg refuses to release the information on the 'Ohio Checkbook' website. It is my contention that the public has a right to know where spent for all public employees. The cities implication that the minor names are redacted for privacy and protection seem disingenuous given public school yearbooks that not only have names of minor children but also pictures. Redacting individual employee various deductions may have merit; however, the redacting of departmental totals and grand totals on the report is suspicious and renders the balancing of the reports almost impossible; an example would be how much are the employees contributing to the Healthcare Plans, that is also redacted I believe, but if it is redacted, the public will never know.
