

## Annual Wellness Visits (AWV)

The purpose of the Annual Wellness Visit is to review the patient's wellness and develop a personalized prevention plan. This visit serves as an opportunity for providers to improve quality of care, assist in patient engagement, and optimize payment opportunities.

- Annual Wellness Visit, initial (G0438)
  - Eligibility begins after the first 12 months of Medicare coverage
  - Welcome to Medicare Visit (G0402) may take place within the first 12 months
- Annual Wellness Visit, subsequent (G0439)
  - Cannot take place any sooner than 12 months after the Initial AWV
