There have been significant favorable changes in the practice of medicine resulting from factors such as technology, public laws and policies, introduction of new drugs and drug regimens, higher expectations of care by patients, specialization, preventive services and more.

Making changes in our own backyard and practices to heighten our effectiveness represents a step forward that we cannot ignore. Patient and staff engagement is essential and its success will be based on factors such as: Feeling understood and recognized when goals are achieved; A clinical, professional and welcoming office atmosphere; Transparency; and The availability of tools and resources to support good outcomes.

I believe that the rise and use of direct contracting to support value-based care are timely and could prove to revolutionize how we deliver services for not only seniors but all segments of the population. I am excited and eager to learn more about CMS specifications for Direct Contracting and positioning CVCHIP to actively participate. I am concerned, however, about the stronghold of health disparities and have placed as a priority, participation in efforts to correct this deficiency as positive change has been slow.

CVCHIP, its member practices and partners merit applause and appreciation for their commitment to level the playing field so that care is available to the same extent to all irrespective of social economic status, age, gender and race.



Dr. Rebecca Lee Crumpler is the first African American woman to receive a Medical Degree (MD) in the United States. She was born in 1831 in Christiana, Delaware to Absolum Davis and Matilda Webber.

Dr. Crumpler challenged the prejudice that prevented African Americans and women from pursuing medical careers. On March 1, 1864, Crumpler received a "Doctress of Medicine" from the New England Female Medical College. She was 33 years old. She remains the only African American woman to receive a medical degree from the school which merged with Boston University Medical School in 1874,

Build your path to better kidney care


Three ways you can build your personalized path to better kidney care:

CMS Redesigns Accountable Care Organization Model to Provide Better Care for People with Traditional Medicare

PRESS RELEASE: Feb 24, 2022

Building on the Biden-Harris Administration's priorities for a better health care system, today the Centers for Medicare & Medicaid Services (CMS) announced a redesigned Accountable Care Organization (ACO) model that better reflects the agency's vision of creating a health system that achieves equitable outcomes through high quality, affordable, person-centered care. The ACO Realizing Equity, Access, and Community Health (REACH) Model, a redesign of the Global and Professional Direct Contracting (GPDC) Model, addresses stakeholder feedback, participant experience, and Administration priorities, including CMS' commitment to advancing health equity.

In addition to transitioning the GPDC Model to the ACO REACH Model, CMS is canceling the Geographic Direct Contracting Model (also known as the "Geo Model") effective immediately. The Geographic Direct Contracting Model, which was announced in December 2020, was paused in March 2021 in response to stakeholder concerns.

"The Biden-Harris Administration remains committed to promoting value-based care that improves the health care experience of people with Medicare, Medicaid and Marketplace coverage," said CMS Administrator Chiquita Brooks-LaSure. "To fulfill that commitment, CMS, through the Innovation Center, is testing new models of health care service delivery and payment to improve the quality of care that people receive, including those in underserved communities. The Innovation Center is making improvements to existing models and launching new models to increase participation in our portfolio, and CMS will be a strong collaborator to health care providers that participate in those models."

As CMS works to achieve the <u>vision outlined</u> for the next decade of the Innovation Center, CMS wants to work with partners who share its vision and values for improving patient care, guided by three key principles. First, any model that CMS tests within Traditional Medicare must ensure that beneficiaries retain all rights that are afforded to them, including freedom of choice of all Medicare-enrolled providers and suppliers. Second, CMS must have confidence that any model it tests works to promote greater equity in the delivery of high-quality services. Third, CMS expects models to extend their reach into underserved communities to improve access to services and quality outcomes. Models that do not meet these core principles will be redesigned or will not move forward.
