This Agreement shall stay in effect from the date initially sign it until it is revoked in writing by DJB. You do not need to sign this Agreement each time you leave your dog at DJB to be bound to the terms of this Agreement including the Release.

By signing this Agreement you agree that you have read and understand all terms and conditions of this Agreement including the Release on the following page and you accept and agree to all terms and conditions of this Agreement including the Release on the following page. Client also warrants that they are the owner of the dog(s) listed in this Agreement and have authority and right to enter into this Agreement and Release and agree to hold DJB harmless from claims of any other parties related to the dog(s) listed in this Agreement and Release.

**RELEASE OF LIABILITY AND WAIVER**

THIS IS A RELEASE OF LIABILITY. YOU MUST READ AND FULLY UNDERSTAND THIS RELEASE BEFORE SIGNING IT. THIS RELEASE APPLIES TO ALL PETS THAT RELEASOR BRINGS TO DIAMOND J BOARDING AND DAYCARE WHETHER THEY ARE INDIVIDUALLY LISTED ON THE AGREEMENT OR NOT.

Client(s), his / her personal representatives, assigns, heirs, and next of kin hereinafter referred to individually and collectively as "Releasor", hereby releases, waives, discharges and covenants to hold harmless Diamond J Boarding and Daycare, its officers, agents, employees, and owners, hereinafter individually and collectively referred to as "Releasee" from any and all liability to the Releasor(s), for any and all loss or damage or injury to of Releasor's pet or property, including injury resulting in the death of the Releasor(s) pet, unless caused by an intentional act of Releasee.

Releasor(s) further agrees that Releasor(s) shall be solely responsible for the cost of any medical or emergency care that may be needed while Releasor(s) pet is at DJB and agrees to pay for any related costs including Veterinarian bills, medication costs, and any other incidental costs that should arise while Releasor(s) pet is staying at DJB. Releasor(s) agree that should Releasor(s) pet pass away while at DJB, Releasor(s) shall be solely responsible for any and all removal costs and related costs.

Releasor(s) further expressly agrees that this Release of Liability and Waiver is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that if any portion of this Agreement and Release of Liability and Waiver is held invalid, it is agreed that the remainder shall, notwithstanding, continue in full legal force and effect. Releasor(s) states that this Release of Liability and Waiver has been read in its entirety and that he / she knows the contents of same and signs this Agreement and Release of Liability and Waiver of his / her own free and willful act. This Agreement and Release of Liability and Waiver constitutes the entire agreement between Releasee and Releasor(s) and the terms of such is contractual and not a mere recital.

Releasor(s) understands the risks of being on Releasee's property and around animals and understands that these risks can be dangerous and lead to damage to personal property, injury, or death and Releasor(s) fully release and hold Releasee harmless from any damages to Releasor(s) property, including pet, or self including injury or death.

Releasor(s) and Releasee agree that should Releasee be found liable, by any Court of competent Jurisdiction, to Releasor(s) for damages, injury, or death of Releasor(s) pet, the sole and maximum measure of damages shall be the value of the pet. Releasor(s) and Releasee agree that the value of Releasor(s) pet does not exceed one hundred dollars (\$100).

Releasor(s) further agrees that they shall be liable for any damage to Releasee's property, injury to Releasee or its staff, and injury to any other pets at DJB caused by Releasor(s) and/or Releasor(s) pet(s).
