## ARCTIC CHALET DOG BOARDING CONTRACT

Dog Boarding contract between Arctic Chalet Ltd.

and the Owner Client named here: \_\_\_\_\_

We will not accept dogs that show any **aggression towards any humans**. This is to minimize the risk of injury to Arctic Chalet staff who will be caring for the dog. Also we will not accept dogs that bark excessively during the day or that bark at night. This is to ensure peace and quiet on our property for our staff and guests staying with us.

Dogs **may not** be brought to our kennels or picked up outside of business hours which are from 10 am to 6 pm Sunday through Friday. If a dog is picked up after hours or on a Saturday when we are closed there will be an extra charge of \$60.

The Arctic Chalet Ltd. agrees to exercise due and reasonable care to keep the premises clean. The dog(s) is to be fed as per instructions on this form, and to be housed in clean quarters.

The dog(s) will be walked daily or as often as possible or put into a play pen to play either alone or with other dog(s). Incoming dog(s) is to have current Town of Inuvik dog tags if the owner resides in Inuvik. All dogs are boarded and cared for without liability on the part of Arctic Chalet Ltd. for loss or damage from disease, death, running away, theft, fire, injury to persons, other dogs or property by said dogs or other unavoidable causes. If any dog(s) becomes seriously ill, the owner will be notified in case no particular veterinarian has been designated. If the owner does not inform regarding measures to be taken, or if the state of the dog(s) health reasonably demands urgent attention, the kennel will have the right to call the vet or administer medication or give other advisable attention, within discretion and judgment of Arctic Chalet Ltd. Also if your dog damages our kennel facility by chewing on wood or other materials please be prepared to cover those costs. Such expenses will be paid by the owner upon receipt of the said dog(s). If Arctic Chalet Ltd. is not contacted within two weeks of expected date due back, the dog(s) is considered abandoned and Arctic Chalet Ltd. a \$500 fee for rehoming or euthanizing the dog. Arctic Chalet Ltd. will apply receipts from sale against outstanding boarding bills. The owner is required to supply a generous amount of food in a suitable container to keep their dog(s) on its accustomed diet. The owner needs to make sure to provide an ample amount of dog food considering adjustments that Arctic Chalet Ltd. may need to make depending on activity level and outside temperatures. The dog's diet should not be changed a few days prior to boarding or the dog will not be accepted for boarding as changes in diet could cause diarrhea. The owner is required to supply a vaccination certificate, which includes DA2P&PV and Rabies.
