Automotive Accessories – Steer Warms

The heated steering wheel might seem like a modern day luxury item, but, being more exposed to the elements, there was an apparent need for that invention in the early days of

our automotive history.

The adjoining picture shows a Ford Model "T" steering wheel electric hand warmer on display in the automotive section of the Patee House Museum in Saint Joseph, Missouri. The inventor, Reuben S. Smith, listed an address of Kansas City, Missouri when he applied for a patent on 14 March 1913. The patent for the laced-on electric warmer was granted on 19 January 1915.

Reuben Sylvester Smith was born 16 April 1885 in Carthage, Panola County, Texas,



located near the east-central Texas border with Louisiana. Throughout his life he also lived in the states of Oklahoma, Missouri and Louisiana. The U.S. Census indicates the following occupations: 1910 machinist at his own shop in Tillman, Oklahoma; 1920 retail merchant of auto accessories in Marshall, Texas; 1930 manager of an automobile company at Homer, Louisiana. While in Marshall he also owned the Smith Motor Company; Whippet Agency.


His 1913 invention included a switch/rheostat to control the current flowing to the two leather covered sections of resistive wire, mounted at points most convenient for the driver. Wire

cords extending down the steering column to the magneto, and then in later models to the storage battery.

The battery could provide better current to properly warm the driver's fingers as to have better control of the car. The heater was said to draw less current than a single headlight bulb.

Ford Steer Warms were manufactured by the Interstate Electric Company of New Orleans, Louisiana. The Ford Special sold for \$5.00 and the model for other makes was \$7.50.


Reuben Smith also had other related electric heated steering wheel patents dated 1912 to 1915, along with a 1909 patent for an electric hammer.

James Townes Casey of Longview, Texas was a friend of Reuben Smith. Casey was a lawyer and former district attorney in Marshall, Texas. On Friday 4 August 1933 he left his law office in Longview and traveled to Homer, Louisiana to pick up Mr. and Mrs. Smith to take them along on a business trip to Hot Springs, Arkansas. Reuben Smith at that time owned Smith Ford Agency in Homer. Mrs. Smith conducted a ready-to-wear establishment in Homer.

At 1:45 P.M. Casey was driving his Plymouth coupe on Highway 67 (also known as the Texarkana – Hot Springs Highway), about five miles south of Arkadelphia, Arkansas, along with the Smiths as passengers. They travelled at a high rate of speed rounding a curve and veered off onto the gravel shoulder, going out of control, leaving the roadway, overturning several times and hitting a telephone pole. Casey age 42, and the Smiths ages 48 and 42, were all thrown from the car and killed instantly suffering from severe head injuries.

Reuben Sylvester Smith and Abigail Stanton (Crawley) Smith are buried southeast of Marshall, Texas at the Crossroads Methodist












First Presidential Car: A 1909 White Steamer, ordered by President Taft.


Mr. Helmann was on the way to his office on Washington avenue about 9 o'clock. In the tonneau of the car sat a blonde young woman and a young man.

January 6, 2021 BRUMLEY, Mo. — An historical engineering marvel and unique must-visit experience in the Lake of the Ozarks area was closed today. The Missouri Department of Transportation (MoDOT) says the Brumley Auglaize Swinging Bridge is no longer safe for drivers, or even pedestrians.

Commonly known as simply "the swinging bridge," the 500foot-long structure was built in 1931 by bridge-builder Joseph Dice, who planned for it to last 60 years, according to Miller County Museum archives. But it is loved by many in the community and visitors for whom it is a popular sightseeing destination. Brave ones take a drive across, while others prefer to watch from non-swinging, solid ground.
