WHAT TO EXPECT



FIELD DECORUM

We want this to be a great experience for everyone, including our partners - City of Puyallup - who are providing us the fields for this state tournament.

The following rules at Heritage Recreation Center:

1. No use of tobacco/vape products while on-premises, in the field, or parking lot.
2. No use of alcohol products while on-premises, at the field.
3. No consumption of marijuana while on-premises, at the field, or the parking lot.
4. No dogs on the field
5. no skateboards, hoverboards, etc. in or around field area or stands.
6. please not block the view of fans in the stands with “easy ups”, tarps, or otherwise. these shade mechanisms can be used around the field so long as they do not block the view of fans.
7. please put trash in the proper receptacles.
8. there will be a concession stand available with concessions, there may also be food trucks and other vendors for food and beverages. All concessions will accept cash, some will accept credit and debit cards.
9. On field photography/videography is not permitted except by/for specific pre-arranged vendors and news media. If taking pictures or videos, please be considerate and do not block the view of the fans.
10. No parents or spectators are allowed to communicate with players, managers, or coaches after the teams are on the field and take occupancy of the dugouts.
11. Park in parking areas only. Do not park on grass or block traffic.

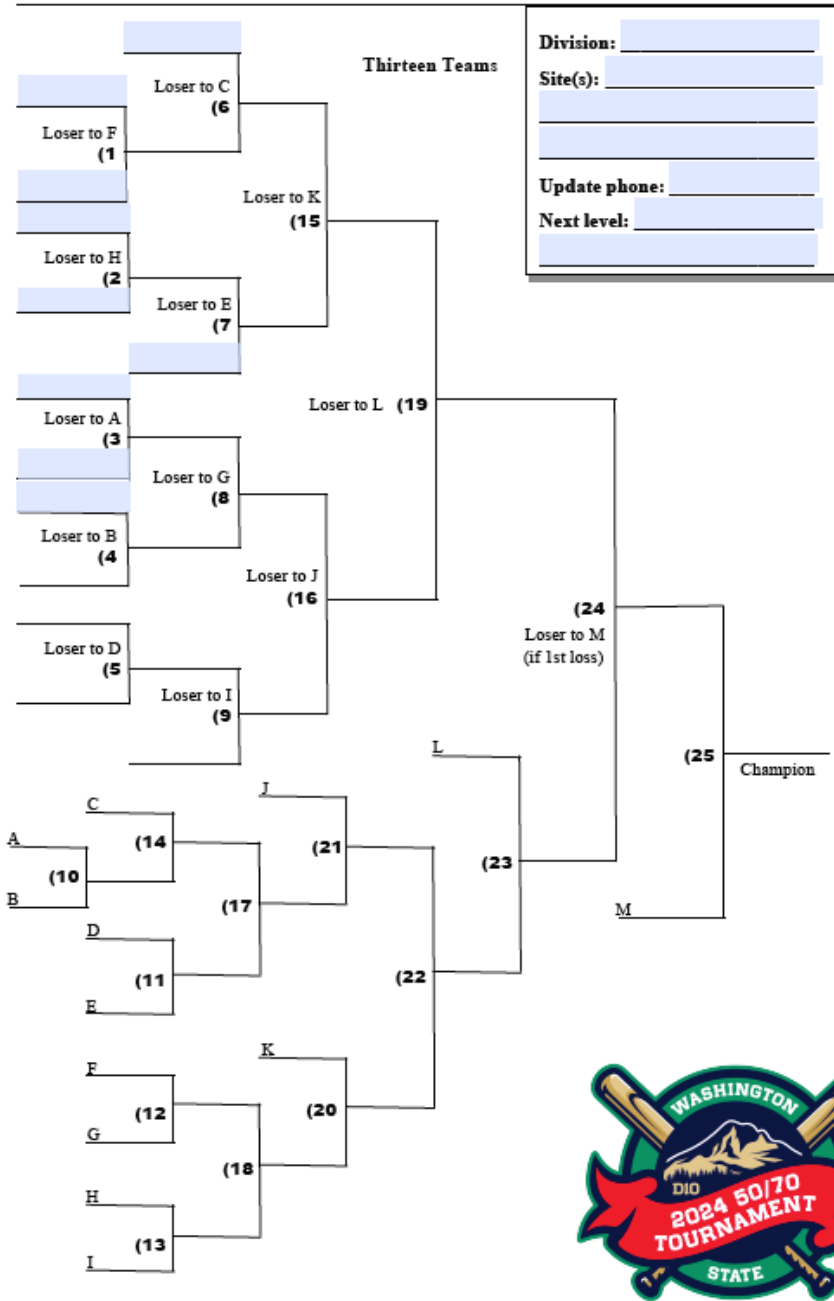
