Oak Hill Water System Improvements

Bids for the construction of the Project will be received at the **New Ellenton Commission of Public Works Offices, 100 Main Street S., New Ellenton, SC 29809, until Tuesday, August 12, 2025, at 2:00 p.m. local time.** At that time, the Bids received will be **publicly** opened and read.

The Project includes the following work: **Approximately 780 linear feet of 10-inch DI water main, 30 linear feet of 18-inch steel casing pipe via jack & bore, altitude valve vault, fire hydrant, related appurtenances, demolition and removal of an existing 2,000-gallon hydropneumatic tank, and the installation of 346 linear feet of chain-link fencing.** The project will establish a permanent connection between the Oak Hill and New Ellenton Commission of Public Works water systems.
