

2025 EXHIBITOR RULES, REGULATIONS, AND INFORMATION

LOCATION AND DETAILS:

The Exhibit Hall opens to attendees on Sunday, January 26th, 2025 at 1:30pm and closes Wednesday, January 29th, 2025 at 12:00pm.

Exhibits for the 2025 Winter Symposium will be held at DoubleTree by Hilton, Colorado Springs, CO. The booth floor plans can be found on our website and have been depicted as accurately as possible. The Winter Symposium reserves the right to make modifications, as necessary, to meet the needs of exhibitors, attendees, and staff.

Each booth is 8' wide x 3' deep x 8' high, with one fully draped table, two chairs and one wastebasket. The exhibit booth walls and table drapes will be royal blue.
