V.I.P. - PHYSICIAN WORKFLOW:

The V.I.P. Physician Work Flow flow is fairly straightforward and ensures our physicians remain in complete control of the treatment process.

V.I.P. ASSESSMENT: Each Veteran is assessed via their application and a V.I.P. Zoom meeting with V.I.P. CEO Micaela Bensko, engaging each Veteran in:

- Understanding the role of “stem cells”, what they are, and what they are NOT, their place in the field of OrthoBiologics, and their limitations for use within compliance guidelines.
- Confirming V.I.P. is solely a facilitator and only promises a thoughtful Tele Consult with a V.I.P. Physician-match, who is then in complete control of approval or denial of each case.
- Grounding each Veteran in the unpredictability and length of an OrthoBiologics procedural recovery.
- Explaining the importance of a multidisciplinary post procedural support system offered to each Veteran and our extensive network of options available to them through our program.
- Confirming proof of service via their DD214 and Govt Issued ID
 - Prepping the Veteran so he/she is FULLY prepared for a Consult with

related imagery / medical records, & reports IN-HAND and instructed to eliminate all NSAIDS/Alcohol 14 days-prior, and to increase hydration pre and post if accepted for treatment.

MATCHING: Once a V.I.P. Physician Accepts a Patient Summary, VIP STEPS BACK!

1. Once we declare candidacy of a V.I.P. Veteran Applicant, we will submit their patient-summary to a selected Physician who then informs as to acceptance or refusal of the case.
2. If bio-product or Kit is needed, please contact us for procurement of contribution via one of our qualified partnerships. 3. Once a procedure has been completed, please send us a donation estimate in “invoice” format for the overall value of services rendered per Veteran, and VIP will remit your official Tax Donation Letter. *
4. Postoperatively is where Vip steps back in and coordinates postoperative multidisciplinary solutions available at no cost to our V.I.P. Veterans through our partnerships through Chord Health and Amp Recover, virtual online physical therapy platforms, Naturopathic Guidance through certified & dedicated practitioners, psychological and emotional support through our “V.I.P. Cell Mate” program - uniting our program’s post-operative Veterans with our V.I.P. ‘Sponsors’ for the first 12 months of recovery who have undergone a prior yet similar procedure and recovery.

You may treat as few or as many Veterans as you feel comfortable, and are never under any obligation to accept a Veteran submission.

What is most important, is for each experience to bring meaning to the lives of both the Veteran and well as the physician.

*Letters of acknowledgement must be reviewed by an independent Account manager as to any possible tax-related benefits in accordance to state law.
