

## Quick Reference Resource to Complete the Local Unit Organizational Structure Form

Local Unit Uniform bylaws went into effect Wednesday, July 21, 2021, for ALL local units. The organizational aspects of your local unit PTA which were approved by your members and documented in previously approved versions of our bylaws template are now required to be documented in the Local Unit Organizational Structure Form. Your local unit is therefore no longer responsible for a five-year renewal process, but rather maintaining an up-to-date Local Unit Organizational Structure form in MemberHub. If you need to change an aspect of your operating structure, your PTA should give members 30-days notice prior to a vote on the proposed change(s).
