PEDDLING / SOLICITING / CANVASSING APPLICATION PROCEDURES AND REQUIREMENTS

All applicants must comply with the following procedures. Failure to adhere to these requirements may result in delays or denial of the application.

1. Applicants shall visit tfpolice.org or tintonfalls.com and review all posted instructions in their entirety before submission.
2. The application must be completed either electronically via the website or submitted in printed form.
3. All applicants are required to schedule and complete fingerprinting through www.identogo.com using service code **2F17ZY**.
4. A copy of the fingerprinting receipt must be submitted via email to policereports@tfpolice.org
Fingerprint results may take up to ten (10) business days to be received.
5. All individuals who will be soliciting must submit a current **2" x 2" photograph** via email for identification purposes. policereports@tfpolice.org
6. All required fees must be paid online through tfpolice.org under the Payments section (Police). **Reference Number:** Company Name.
Applications will not be processed without confirmed payment.
7. **Fee Schedule:**
 - o **Business Application:**
A business entity shall pay a **\$100 license fee** per application. Each solicitor operating under the business must obtain an identification permit for **\$10** per person.
 - o **Individual Application:**
A single applicant shall pay a **\$100 license fee** plus **\$10** for the required identification permit.
8. Upon receipt of all required documentation and fees, applicants will be contacted to schedule an appointment with the Police Department.
All individuals listed on the application are required to appear in person at the scheduled appointment.
9. Identification badges will be issued at the Police Department. Said identification must be carried on the person and always displayed in a clearly visible manner while engaging in soliciting, canvassing, or peddling activities.
10. *No identification will be issued until all application requirements have been satisfied.*
11. Applicants are responsible for reviewing and complying with all addresses listed on the Borough's "**No Knock**" **Registry**, available at tfpolice.org and tintonfalls.com. Solicitation at these addresses is strictly prohibited.
