

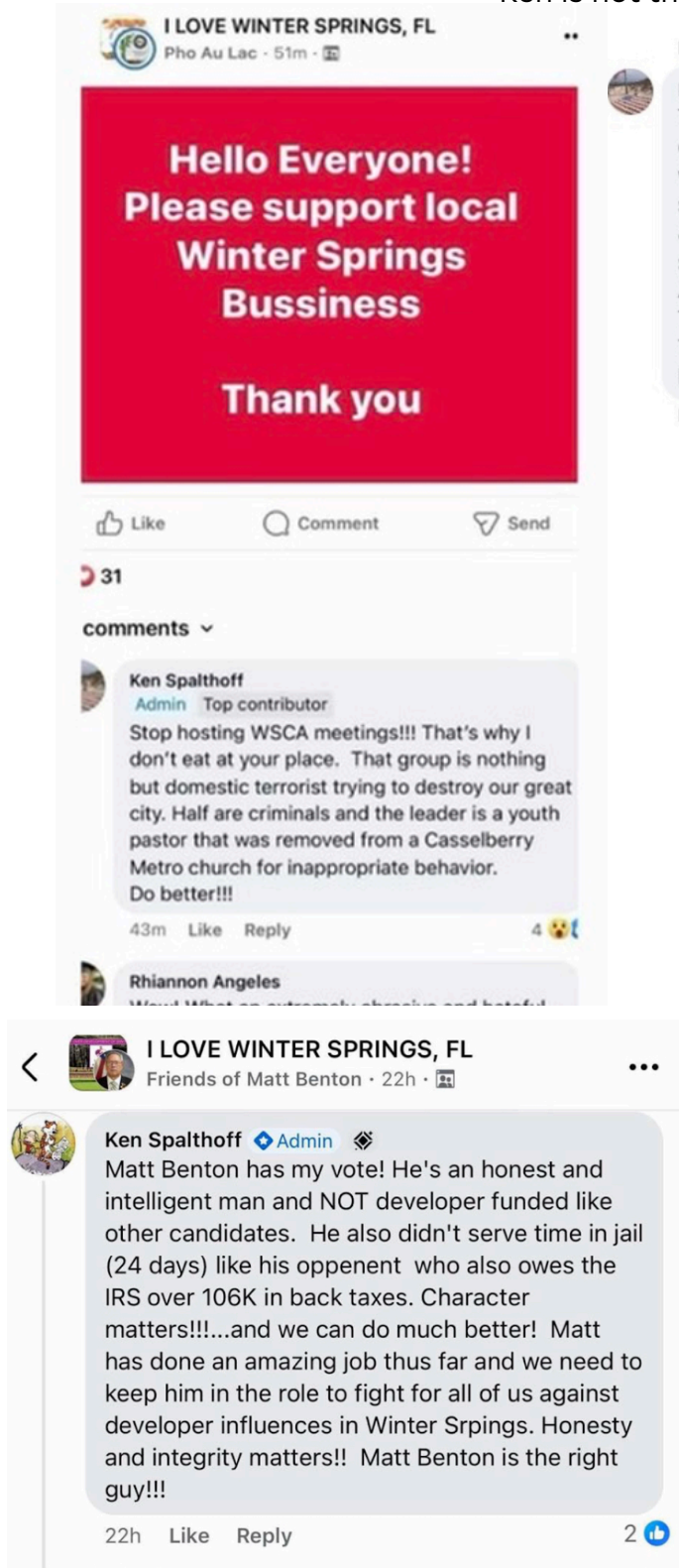

Ken is not the victim he claims to be.



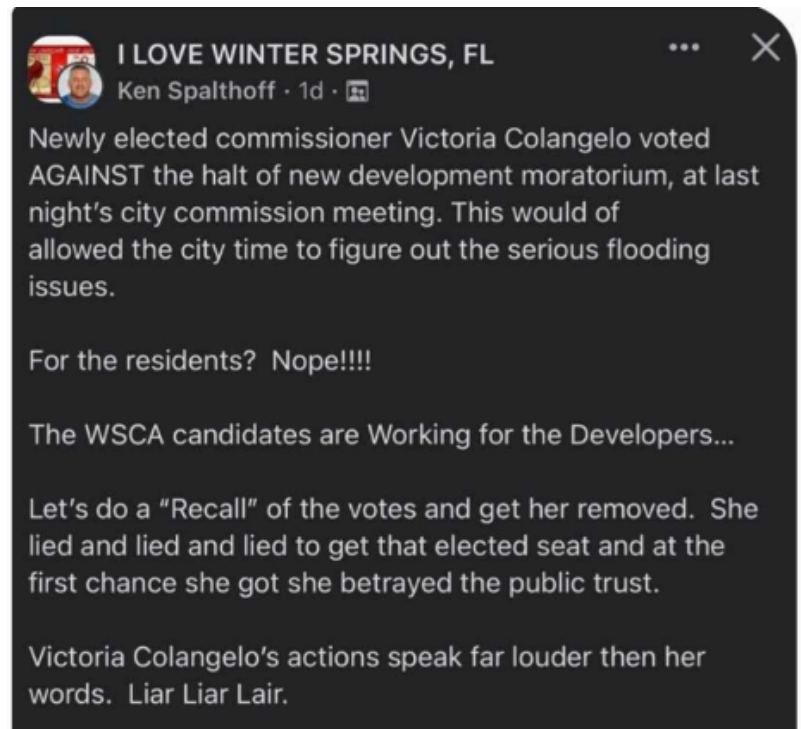

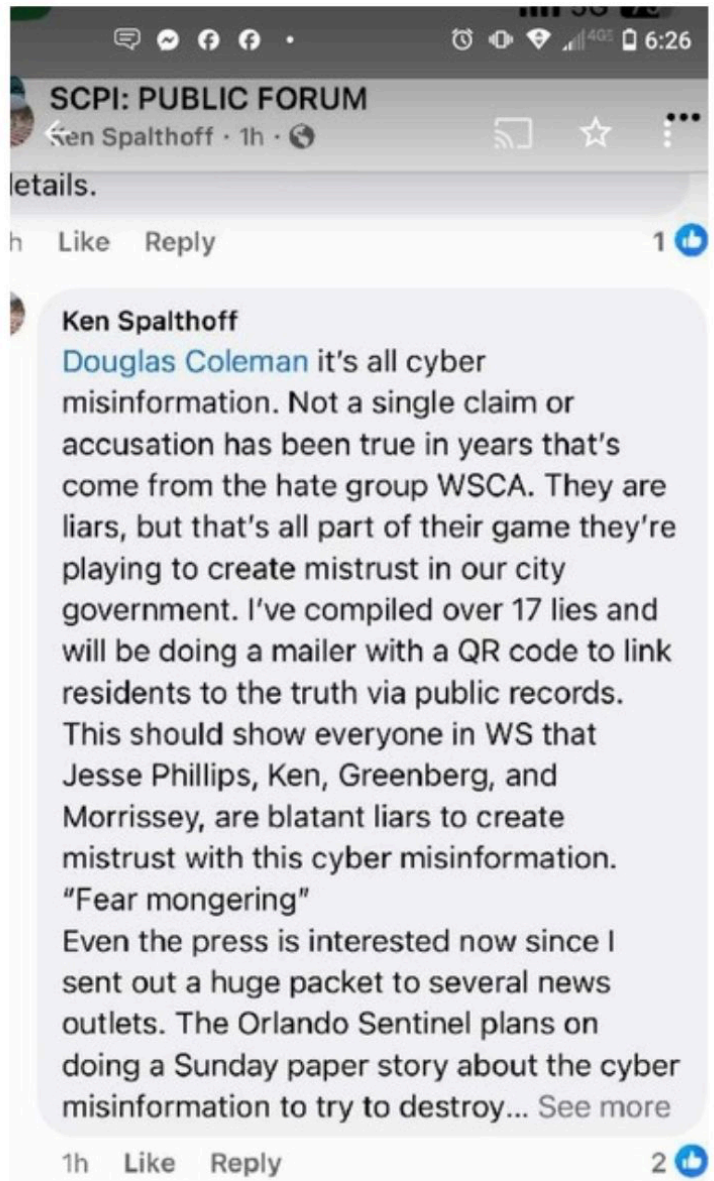

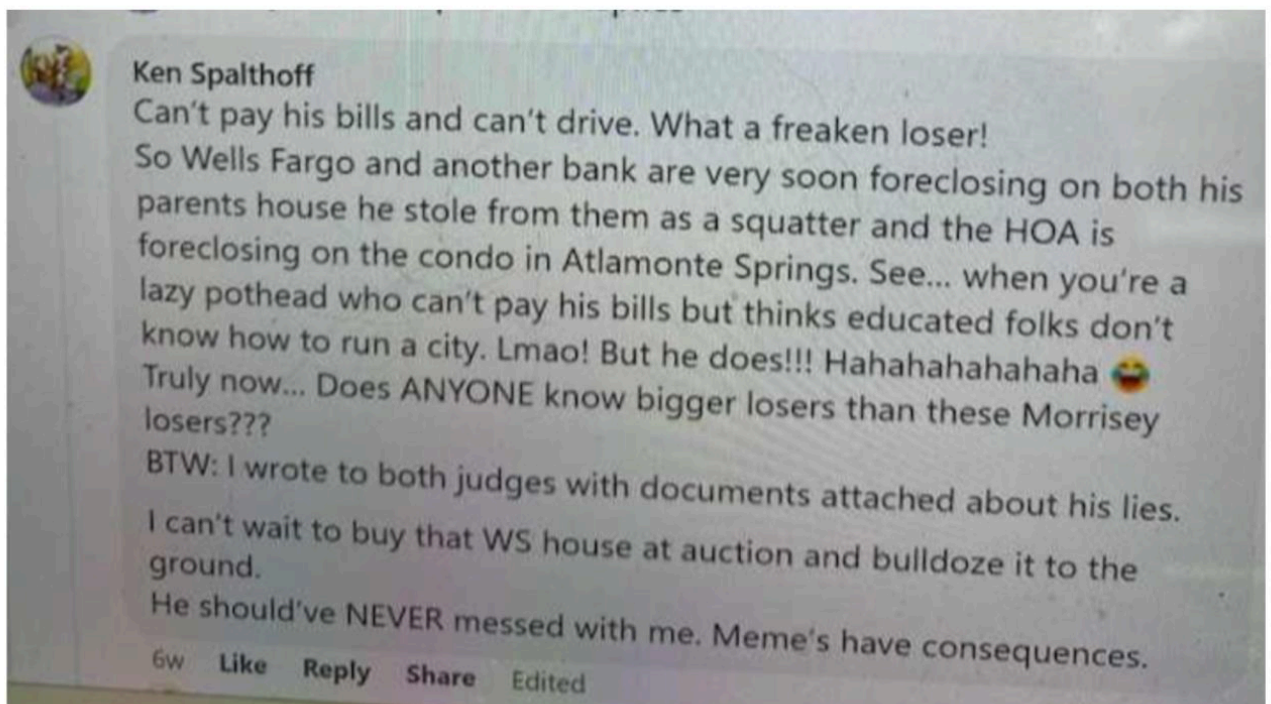
