Mission Stewardship Moment from eSwatini:

On any given day, countless numbers of people flow through the door of the Justice,

Peace and Reconciliation Department of the Council of Swaziland Churches. Simply known as "JPR," the department is comprised of a team of dynamic lawyers who work tirelessly with a spirit of humility, integrity, and compassion in championing human rights and social and economic justice for all. This work is not only accomplished through broader platforms but daily with ordinary individuals who stem from the four regions of the Kingdom of Eswatini.

"My mother said, 'I don't have much time left. Take me there to do my will,'" states Mr. W. Dlamini who accompanied his nonagenarian, vision-impaired mother to the office. Similarly, some new clients present to the office for consultation or to initiate the process for simple legal matters. Others reveal that they have been on long, ardent journeys in their quest for a resolution with matters concerning: restorative justice, child maintenance, marriage law, conflict transformation, physical or sexual abuse, inheritance, and individual and property rights. They come to the church, which is a beacon of light and renewed hope, for legal assistance with situations that have left them frustrated and unable to see a feasible resolve.

"I have tried different places and never experienced any progress with my case. Now that I have come here, things are happening! I am impressed with the progress that is being made," exclaims
