The name of a registered Paint Horse can be changed if the horse:

- 1.) has not earned any points in an ATOA approved show or contest has not been named Grand or Reserve Champion or established a show record based on class wins.
- 2.) Has no registered offspring, or
- 3.) Has not compiled a record in programs recognized by ATOA.

If your Paint Horse meets these qualifications:

1. Submit the original registration certificate
2. Complete this form and have it notarized for (or provide a copy of your photo ID in lieu of notarization)

**Please provide at least three name options.** Do not use punctuation marks or numbers. Name may not exceed 21 characters and spaces combined. Do not use names that sound similar to existing names, even if spelled differently.

## **\*\*Notary**

- This form must be notarized and completed in its entirety.
- Members may submit a photocopy of a photo ID in lieu of notarization.

## **\*\*Fees**

- All fees subject to change.
- All fees required to complete the work will be charged.
- An office processing fee will be charged on all work not processed to completion.
- Work is done in the order it is received. The RUSH fee moves your work to the front of the line.
  - \*Envelope marked \*RUSH\*
  - \*Daytime phone number
  - \*Certified funds or a credit card payment on file.

The Rush fee will not be refunded. Minimum processing time for rush service is 10 business days from date received.
