2026 Breeders Legacy Stallion Enrollment Instructions

1. Eligibility & Ownership

- The stallion must be subscribed under the **recorded owner or lessee’s name** with ATOA records.
- If someone other than the recorded owner or lessee wishes to enroll the stallion, a **signed waiver** from the owner/lessee must accompany this form.
- If a mare owner or resulting foal owner requests the waiver, late fees will be **waived through May 15** of the foaling year.

2. Enrollment Fees

The stallion enrollment fee is paid in **two installments** each year.

The total stallion enrollment fee will **never exceed the stallion’s advertised stud fee** for that breeding year unless late fees apply.

Stallion Type	Initial Enrollment Fee (Due Jan 31)	Final Enrollment Fee (Due Nov 30 per mare on SBR)
ATOA Registered Stallion	\$150	\$100 per mare

- Stallions standing for the **first time** have until **March 31** to pay the initial fee without penalty.
- If a stallion is **purchased between February 1 and June 30**, enrollment may be completed **within 30 days of purchase** without late fees (proof of sale required).
- Transfers between individuals or entities owned in part or whole by the same person do **not** qualify for late fee waivers.

3. Late Fee Schedule
