2025 Breeders Legacy Program- Foal Nomination Instructions.

Please Note the Following:

1. Sire Eligibility

The foal's sire must have been **enrolled in the ATOA Breeders Legacy Program** for the breeding year in which the foal was conceived.

(Foals by non-enrolled stallions are not eligible for nomination.)

2. Nomination Ownership

The foal nomination must be made in the name of the **Foal's recorded owner or lessee** on file with the **American Tobiano Overo Association** at the time of nomination.

3. Eligibility for Nomination

A foal is **not eligible** for nomination if it has already earned points or awards in any ATOA-recognized or approved competition prior to nomination.

4. Required Documentation

Please include all of the following with your nomination form:

- a. **Original Registration Certificate** (if foal is already registered), or
- b. **Registration Application** (if foal is not yet registered). And
- c. **Appropriate nomination fee** (see fee schedule below)

Nomination will not be processed if required documents or fees are missing.

Foal Nomination Fee Schedule

by December 31 of foaling year	\$100	must be nominated before the foals first year
by 12 th month of age	\$200	must be postmarked by foal's birthdate anniversary
by December 31 of yearling year	\$400	nomination after foaling year but before 2 years old

3 years and older	\$1000	late nomination-eligible only with proof of reg.
