

HORSE SHOW GUIDELINES

To protect others from possible transmission of the COVID-19 virus, anyone who exhibits symptoms or has been in contact with someone who has tested positive for COVID-19 within the last two weeks, cannot enter the competition grounds. Participants must assume responsibility for themselves and their staff.

Face coverings are recommended for everyone on the show grounds, except when mounted. We request social distancing at all times, especially while spectating (whether standing or sitting) and NO lounging areas allowed at the end of barn aisles.

We request all communication with the show office be done electronically. Entries can be done at Horseshowsonline or scanned and emailed to Kelly at kellysue1112@aol.com.

The show grounds will be open starting Monday June 14th at 12 pm.

When coming on to the showgrounds everyone must sign the NEW Waiver and Release form which is available online at www.blueribbonshows.net. We will take everyone's temperature and give you a wristband which must be worn at all times.

No parking next to the barns.

Schooling Area guidelines : (These guidelines may be adjusted/enforced by show management)

There will be a limit of 3 horses schooling at any given time.

Each horse/rider may have 2 people assisting them with jumping.

Each barn can only have 2 horses/riders in the schooling area at any one time.

Only 2 additional horses/riders may be hacking at any time while others are jumping.

In-Gate guidelines: (These guidelines may be adjusted/enforced by show management)

We will limit the number of people at the in gate, and ask that everyone observe social distancing.

Water bottles will be distributed to exhibitors as needed at each gate. There will be no water coolers.

Maximum 2 horses in each Wash Rack. Be sure to bring your own water hoses.

We will provide disinfecting spray bottles for each schooling area and ask that participants use them to spray the jumps before handling.

We ask that you go outside when you use your golf cart to come and go from the rings. We want to keep the aisle ways free of congestion.

Horses will jog for soundness under saddle by trotting a circle on a loose rein at the end of each over fence performance. In Conformation classes handlers must comply with social distancing guidelines.

Ribbons will be available at our awards room at designated times. Be sure to know your class & entry number.

Exhibitors & trainers need to text or email orders for Hay, Shaving & Stalls to Dave Morse 469-223-3283 (email: dam3283@gmail.com) PRIOR to arrival. Additional orders during show are Required to be given to the office prior to noon each day for next day delivery.

Add/Scratch information can be texted/emailed to the horse show office prior to 4pm each day.

All splits must be done prior to 12pm on Friday each week

Ticketed schooling will be available in all rings on Wednesday prior to the start of the show. It will be monitored. A maximum of 5 riders are allowed in the rings at a time. Each session will last no longer than 10 minutes.

Braiding is optional and will not be penalized. All Braiders must follow USEF & CDC guidelines while on the show grounds. All horses should be braided in their respective stalls. Braiders will coordinate their activities with Night Watch.
