Passenger Waiver Form

- I, [Passenger's Full Name], hereby acknowledge and agree to the following terms and conditions as a condition of my participation in the party bus services provided by Austin Vibe Transportation Services LLC.
- 1. Assumption of Risk: I understand and acknowledge that riding on a party bus involves certain risks, including but not limited to accidents, injuries, and property damage. I voluntarily assume all such risks and agree that Austin Vibe Transportation Services LLC its affiliates, officers, employees, and agents shall not be liable for any injuries, damages, or losses that I may sustain as a result of my participation, except where such injuries, damages, or losses are caused by the gross negligence or willful misconduct of Austin Vibe Transportation Services LLC.
- 2. Release and Indemnification: In consideration for being permitted to use the party bus services, I hereby release, waive, discharge, and covenant not to sue Austin Vibe Transportation Services LLC its affiliates, officers, employees, and agents from any and all claims, liabilities, actions, demands, damages, costs, or expenses, including but not limited to attorney fees, arising out of or in any way related to my use of the party bus services. I further agree to indemnify and hold harmless Austin Vibe Transportation Services LLC from any claims brought by third parties arising out of my actions or conduct while using the party bus services. This release and waiver is intended be effective in all situations, including the negligence and/or gross negligence of Austin Vibe Transportation Services LLC, as well as their employees, agents, contractors, and subcontractors. I acknowledge that I (the passenger) am solely responsible for any damage or harm I incur resulting from my participation in this activity.
- 3. Compliance with Laws and Regulations: I agree to comply with all applicable laws, regulations, and rules while using the party bus services, including but not limited to those relating to alcohol consumption, noise levels, and safety precautions. I understand that any violation of these laws, regulations, or rules may result in immediate termination of my participation in the party bus services without refund.

- 4. Alcohol and Substance Use: I understand that alcohol consumption may be permitted on the party bus subject to applicable laws and regulations. I agree to consume alcohol responsibly and to refrain from using any illegal substances while using the party bus services. I further acknowledge that Austin Vibe Transportation Services LLC reserves the right to refuse service or remove any passenger who is intoxicated or under the influence of drugs.
- 5. Personal Belongings: I agree to assume full responsibility for any personal belongings that I bring onto the party bus and acknowledge that Austin Vibe Transportation Services LLC shall not be liable for any loss, theft, or damage to such belongings.
- 6. Seatbelts: Passengers understand the bus is not equipped with seatbelts. Passengers agree to stay seated at all times while the bus is in motion.
- 7. Medical Conditions: I certify that I am in good physical health and free from any medical conditions that may be aggravated by my participation in the party bus services. I agree to notify Austin Vibe Transportation Services LLC of any medical conditions or limitations that may affect my ability to safely participate in the party bus services.
- 8. Governing Law and Jurisdiction: This waiver shall be governed by and construed in accordance with the laws of the State of Texas. Any dispute arising out of or relating to this waiver shall be subject to the exclusive jurisdiction of the courts located in Travis County, Texas. Also, if any part of this document is found to be inapplicable or ineffective, it does not invalidate the other portions of this document.
