Cleveland Park Club

Member Agreement Policy

The Cleveland Park Club ("the Club") exists to foster community, recreation, and friendship among our members. By joining and maintaining membership, each member agrees to uphold the spirit of the Club, respect fellow members, and follow the policies outlined below.

1. Membership & Dues

- Membership is open to individuals and families residing together in a household, plus one childcare provider, as listed in the Member's online account.
- Annual dues are set by the Board and must be paid in full by the published deadline in order to maintain good standing.
- Membership is non-transferable and non-refundable.
- Account credits do not roll over to the following year and cannot be used to renew membership.
- Voting Members in good standing are eligible to vote in Club matters, access the pool, serve on the Board, reserve Club facilities for private events, access swim lessons, attend all social events and meetings at the Club, and receive discounted rates on camp, swim lessons, and other events held at the Club.
- Social Members in good standing are eligible to serve on the Board, access swim lessons, register for camp, and attend all social events and meetings at the Club.
- Camp and Swim Access Members in good standing are eligible to register for camp and swim lessons.

2. Code of Conduct

- Members, their families, and guests are expected to treat others with courtesy and respect at all times.
- Disruptive, unsafe, or disrespectful behavior may result in disciplinary action, including suspension or termination of membership.
- Members are responsible for the conduct of their children and guests while on Club property.
- Voting Members will complete 2 hours of service to the Club annually or be assessed a \$100 Club improvement fee. This fee must be paid before membership can be renewed.

Members will break down all large food container items and will take any waste that
does not fit in the trash receptacles located on the pool decks to the trash receptacles at
the front of the Club property.

3. Guests

- Members may bring guests in accordance with the Pool Rules published annually by the Club.
- Guest fees must be paid at the time of entry.
- Members must remain with their guests while on Club property.
- Guest passes do not roll over to the following year and cannot be used to renew membership.

4. Facilities & Reservations

- The pool is for the use of Members and their guests only.
- Reservations for private events must be made through the Club's reservation system and are subject to approval.
- Members renting the space are responsible for leaving the facilities in clean and good condition after use, subject to the Renter's Agreement.

5. Safety & Liability

- Members agree to abide by all posted safety rules and any instructions provided by Club staff.
- The Club is not responsible for loss, theft, or damage to personal property.
- Members use Club facilities at their own risk and agree to release the Club, its Board, and staff from liability for injuries sustained on Club premises.

6. Governance

- The Club is governed by its Board of Directors, elected from the membership.
- Members agree to abide by the bylaws, policies, and decisions adopted by the Board.
- Suggestions and concerns may be directed to the Board for review.

7. Amendments

This Member Agreement Policy may be updated from time to time by the Board. Members will be notified of any changes, and continued use of Club facilities constitutes acceptance of the revised terms.
