Vendors are responsible for obtaining Denver Sales Permits as required. IN SUBMITTING THIS APPLICATION, I AGREE TO THE FOLLOWING: Remain open for sale during show hours. Only pre-approved items will be sold. NO last-minute additions without approval. Must staff all vendor booths and be responsible for set-up, clean up and secure booths. Comply with the necessary Colorado Health Department regulations and produce a valid Health Department Permit if necessary. Comply with all Fire Codes and have a minimum of (1) 2A10BC certified fire extinguisher in booth. Alcoholic beverages are PROHIBITED on the property. Consumption of alcohol before or during the show hours by vendor and all staff members is prohibited. NO drug or controlled substance related items to be sold or brought onto the show premises. NO pets of any kind are allowed in the food area, near or in any food booths. REFUND POLICY: no refunds due to bad weather or acts of God. Refunds will be made ONLY if a written request is received (2) two weeks prior to the event. A cancellation fee of \$50.00 will be deducted from all refund checks. Any checks returned for insufficient funds are subject to a \$35.00 service fee. I also agree to hold the City of Denver, Jefferson County, Citizen's Park, Redheads Unite, O.U.R. and the officers, agents and employees harmless for any resulting loss or damage occurring to any person(s) or property. Application does not guarantee acceptance into this event.
