

Open Class Showcase Terms and Conditions

1. Exhibitors:

- Must be at least 16 years of age.
- Are not required to be residents of Knox County or surrounding counties.
- Are limited to two entries per class, but may exhibit in an unlimited number of classes.
- Will request placement in a specific Department/Category/Class with rulings made by the Chairperson of the Open Class Showcase or his/her representative if there is a question.

2. Exhibits other than Antiques/Vintage:

- Must fit into a class listed in this booklet. Rulings on class fit will be made by the Department Superintendent or the Open Class Showcase Chairperson.
- ♦ Must be handmade, prepared, or grown by the exhibitor.
- Must have been completed within the past 2 years.
- Must not have been exhibited previously at the Knox County Fair through the Open Class Showcase.
- Must meet the guidelines of the Department in which they are to be entered.

3. Project Entry Schedule:

- ♦ Thursday, July 13, 2023: 4:30 pm-7:30 pm, non-perishables only.
- Friday, July 14, 2023: 7:00 am-11:00 am, perishables and non-perishables.
- 4. Entry Fees: \$1.00 per exhibit. Payments must be in cash or by check.
- 5. Judging Schedule: Friday, July 14, 2023, from 12:00 noon until finished.
- 6. Placing: All exhibitor information will be withheld from the judges.
 - ♦ Each class with a minimum of three (3) entries will have a 1st, 2nd, and 3rd placing. Classes with less than three (3) entries may be combined with other classes under the same category and judged as one class. Combining classes will be done at the discretion of the Department Superintendent or Open Class Showcase Chairperson and will be completed prior to judging. No 1st or 2nd place ribbons will be awarded automatically to classes with less than three (3) entries as items will be judged on their own merit. No "Exhibitor" or "Honorable Mention" ribbons will be awarded.
 - Each 1st place in a class will be considered for the category champion and reserve champion placing if there is a minimum of two (2) 1st place exhibits in the category.
 - Each champion placing in a category will be considered for the Department Grand Champion and Reserve Champion if there is a minimum of two (2) champion category placings.
 - ♦ Rulings on department/category/class placement will be made by the Department Superintendent or the Open Class Showcase Chairperson.
 - The judge in a Department/Category will have the final decision on the placing of an entry.
- 7. Judging: Depending on the Department and Category, exhibits will be judged with the following qualities in mind: workmanship, preparation, cleanliness, condition, taste (culinary arts/beer brewing/wine making), suitability of purpose, color combination, beauty, and originality. Entries in the Antique/Vintage Department may also be judged based on the rarity/uniqueness of an item. Judges reserve the right to place entries on factors they consider important/necessary to the specific category in which they are judging.
- 8. Premiums: No premiums will be issued for placings.

- 9. Professional/Non-Professional Exhibitors: Both Fine Arts and Photography have separate categories for professional and non-professional exhibitors. A professional photographer, artist or craftsman is one who is in the photography, arts or crafts teaching profession or doing extensive exhibiting or selling of their work. A professional photographer, artist, or craftsman may have a business card, website, or Facebook page to promote their work. Once a photographer, artist, or craftsman has exhibited as a professional in a specific category, the photographer, artist, or craftsman may not return to that category as a non-professional.
- 10. Safety/Security: Every precaution will be taken to ensure the safety and security of the exhibits; however, in no case will the Knox County Fair Board or the Open Class Showcase be held responsible for the loss or damage of any exhibit.
- 11. Pictures: The Open Class Showcase reserves the right to take and use pictures of exhibits for future publicity of the Open Class Showcase or the Knox County Fair. Those exhibitors who receive **Grand Champion Ribbons** will be given the opportunity to have their picture taken by the Vincennes Sun Commercial at a time to be determined later.
- 12. Hours of Building Operations: The Open Class Showcase in the C. James McCormick Event Center will plan to follow the open hours of the 4-H Building with the exception of Friday, July 14, when the Open Class Showcase will not be open. Hours of operation will be dependent upon the ability to provide adequate staffing. The Open Class Showcase will be open beginning at 11:00 am on Saturday, July 15, and will follow the schedule indicated on Page 2 of this Exhibitor Information Booklet. Hours of operation also will be posted on the door of the C. James McCormick Event Center.
- **13. Release of Exhibits:** Exhibits will be released from 7:00 pm to 10:00 pm on Friday, July 21, and from 9:00 am to 11:00 am on Saturday, July 22, 2023.
 - ◆ The Open Class Showcase has the right to dispose of all perishables, no later than 11:00 am on Saturday, July 22, 2023.
 - All exhibits/ribbons not picked up at these times will be held in the Knox County Fair Office until July 26, 2023. If an exhibitor is unable to pick up his/her exhibits/ribbons during the designated time periods, he/she must make arrangements with the Open Class Showcase Chairperson prior to 11:00 am on Saturday, July 22, 2023. Exhibits/ribbons not picked up by September 30, 2023, will be returned to the Open Class Showcase inventory.

From the Open Class Chairperson:

The Knox County Fair needs help in promoting the continuation of the arts that have been essential throughout the history of the world. Youth have 4-H to teach them these skills but help is needed to preserve these skills throughout adult life. Although much can be done with automation and mass production and many items can be easily purchased, there is nothing that matches the taste of homegrown tomatoes, homemade jellies, or home baked bread or the beauty of a handmade quilt, crocheted afghan, or original oil painting. Efforts are needed to keep these creative, culinary, and cultural arts alive!

Yet, it's "not your grandmother's open class anymore!" Open Class Showcase exhibitors go beyond the traditional Home Extension Clubs and categories of "homemaking" from previous years. Many of the "new" artistic skills have been added such as scrapbooking, photography, structural arts (i.e., Legos), cake/cupcake decorating, coloring, home beer brewing, etc. to keep up to date with current interests.

Antiques/Vintage

Terms and Conditions:

Entries:

- Must be 50 years of age or older.
- ♦ Should be clean and in good condition.
- Can be no larger than 30" square or 12" in depth and must weigh less than 20 pounds.
- Can not have been entered in the Open Class Showcase within the last 5 years.
- Are limited to one entry per class per exhibitor. Unless otherwise indicated, a class entry is one item.
- May be combined into one category if there is less than 5 total items in the category.

Ceramic/China Painting

Terms and Conditions:

- ♦ All entries must be hand-painted (decals are not accepted).
- All entries should be submitted to the Crafts Department Superintendent but will be judged as a separate department.
- The item that has been hand-painted need not be made by the exhibitor; however, the painting and glazing must have been completed by the exhibitor.

Culinary Arts

(Formerly Baking)

Terms and Conditions:

All exhibits must be submitted on paper plates, cardboard, or in disposable pans and be covered with clear plastic wrap or placed in a sealed zip-top plastic bag.

All exhibits should include the recipe used.

Filling, frosting, glazing, pie filling, and meringue (whether cooked or uncooked) are not permitted to contain cream cheese, whipped cream, sour cream, unpasteurized milk or eggs/egg whites. Pasteurized eggs or eggs cooked to 160 degrees before use may be used.



Home-canned fruits, vegetables, or meats are not permitted as ingredients.

Exhibitors must follow food safety guidelines while preparing exhibits. They must carefully wash their hands and make sure that their hands do not have any open cuts before preparation. Use of gloves is encouraged.

Baked goods should be transported and stored in chilled coolers.

Exhibitors should provide the number of items indicated for the class. One piece will be used for judging and one piece will be used for the exhibit. The remaining food items will be sold after judging (with the exhibitor's permission) with proceeds being provided to the Knox County Fair Board, Open Class Showcase.

All entries must be created by the exhibitor.

^{**}Structural creations should be no longer than 18" wide x 24" long x 18" high and should be submitted on a base affixed to foam or core board. Entries should be solidly constructed to allow for displaying. The Open Class Showcase is not responsible for maintaining the structure of the entry.


Fiber Arts

(Formerly Needlework)

Terms and Conditions:

- ♦ Exhibits must be created by the exhibitor.
- ♦ All pictures and wall hangings must be ready to hang with a wire hanger or dowel rod.
- Entries must not be soiled or smell of smoke.

- Exhibitors may be Professional (P) or Non-Professional (NP) artists and must designate which category they wish to be in at the time of entry.
- Entries must have been made by the exhibitor.
- All pictures must have a stiff backing and be ready to hang with wire fasteners.
- Entries may not contain content or subject matter deemed objectionable.

Floriculture

(Formerly Flowers)

Terms and Conditions:

- Entries have a 2 foot by 2 foot space limit for width and depth.
- Entries have no height limit.
- ♦ All flowers must be real (no plastic, silk, or other material).
- ♦ Flowers in the "Perfection of Bloom" category must be grown by the exhibitor and exhibited in a bottle with the greenery on the stem.
- Flowers in "Arrangement" categories may be purchased (as opposed to grown) but must be arranged by the exhibitor.
- Exhibitors should replace flowers during the week to keep fresh if possible.


Food Preservation

Terms and Conditions:

Entries must:

- Be canned by the exhibitor.
- Use either quart or pint size standard jars or jelly jars.
- ♦ Have a label.
- Be sealed with two piece standard canning lids.
- Have canning jar rings with the exhibit.
- Have no decorations on the jar.


Home Brewed Beer & Wine Making

Terms and Conditions:

- Beer and wine must be made by the exhibitor and entered under the maker's name, not the brewery/winery.
- ♦ The content of the bottles will be disposed of after judging as no alcohol is allowed on the Knox County Fair Grounds.
- The bottles must not be labeled with the maker's name or brewery/winery.

Terms and Conditions:

- Exhibitors should provide the number of items indicated by the class name. One item will be lit, cut, or opened for judging and one will be maintained for display. Exhibitors will designate the class in which their product should be judged.
- Exhibitors should include a list of ingredients of their product and any special features the product provides.

- ♦ Exhibitors may be professional or non-professional photographers and must designate which category they wish to be in at the time of entry.
- ♦ Exhibits may be any size up to 11 x 14 inches (including matting).
- ♦ Entries must be permanently mounted on photographic mount board.
- Entries must be ready to hang.
- Mats are required; no frame or under glass accepted.
- Photos should not be more than 3 years old.
- Exhibitors may not enter two photos of the same subject.
- ♦ Hangers will be available for purchase at the entry table .

- The Department Superintendent will make the final decision as to which class the item will be entered.




Terms and Conditions:

Entries are limited to 12 square feet in size. Entries may be more than one piece.

Exhibitors may be asked to exhibit only a part of a project after judging due to space limitations.

Category	Classes
A. Wood Carving	Item made with cutting tools (knives, chisels, and mallets) such as a bird, figure, animal, design/relief, plate, picture, utensil (2 pieces), etc.
B. Joinery: Hand- mades	Item made from cutting and joining wood pieces that are smaller than 2 square feet (i.e., toy, small furniture, doll house furniture, décor, etc.)
C. Joinery: Large Handmades	Item made from cutting and joining wood pieces that are larger than 2 square feet (i.e., furniture, toy, doll house, décor, etc.)
D. Wood Turning	Item made using a lathe with hand held tools to cut a shape (i.e., bowl, box, vase, rolling pin, ornament, candle holder, egg cup, chess pieces (4 pieces), etc.)
E. Wood Burning (Pyrography)*	Item made containing images that have been burned into the wood surface* (i.e., picture, cutting board, jewelry (1 item or pair of earrings), spoon (2), frame, box, coaster (2), etc.)
F. Made from Kit	Small (less than 2 x 2), Large (over 2 x 2)

*The item that the pyrography is on does not have to be made by the exhibitor; the pyrography itself has to be completed by the exhibitor.
