Vendor shall operate only under the Business name (DBA) described above. Vendor products, Tent set-up, Vehicle parking, signs, and displays are subject at all times to approval by Car Show Committee. Vendor space is restricted to employees or representatives of this named vendor. All Vendors are responsible for safety and legality of its space and must comply with all applicable laws & regulations & assumes full responsibility if any laws are broken. The Regular Food Vendor space is 15' x 20. See payment information below.

#### All Vendors must supply their own power!

<u>Tent Requirements</u> -All spaces using a tent must have a tent <u>CERTIFIED</u>, by NFPA701 SPECIFICATIONS.

<u>Food Trucks and Food Trailers</u> – All Food trucks and / or Trailers must be Insured and Licensed.

All vendors must also provide at least a **10lb A-B-C Fire Extinguisher.** This will be enforced by the North Haven Fire Marshal.

### **INSURANCE REQUIRMENTS:**

All Vendors are Required to supply a \$2,000,000.00 LIABILITY INSURANCE CERTIFICATE naming St. Elizabeth of the Trinity Parish and the North Haven Sons and Daughters of Italy Lodge 2805 as certificate holders and additionally insured.

Proof of insurance coverage must accompany this Agreement and the necessary permits/licenses must be displayed in your SPACE during Car Show. **THERE WILL BE NO EXCEPTIONS!** 

<u>LIABILITY</u>: Vendors agree to Indemnify and hold harmless the North Haven Sons and Daughters of Italy Lodge 2805 and The St. Elizabeth of the Trinity Parish, any members of the North Haven Sons and Daughters of Italy Lodge 2805, any St Elizabeth of the Trinity Parish officials or employees, any co-sponsors, promoters, or any of their representatives or employees for any personal injury or property damages, liabilities, losses, attorney's fees or costs resulting from negligent acts of vendors.

<u>PERMITS: FOOD</u> Vendors are required to obtain Health Permit 14 days in advance from the Quinnipiac Valley Health Department.

Vendors will not be allowed to set up and operate if Vendor does not follow rules and regulative	ons.

**PAYMENT:** A 15 x 20' space is \$50.00. A Security Deposit of an Additional \$25.00 is required, this will be 100% refunded after Car Show is completed, providing the vendor space is left in satisfactory condition and meets all the Cleanup, Health Department and Fire Department Requirements. Please make 2 checks payable to North Haven Sons and Daughters of Italy Lodge 2805, One for \$50.00 and the other for \$25.00 for the refundable Security Deposit. We must receive full payment before July 1, 2022.

#### **RESTRICTIONS:**

Vendors are allowed to sell only products agreed upon with NHSDI Lodge 2805 Car Show Committee which are list in this document. You are not allowed to solicit or promote anything other than the items listed on this document. No items or products bearing the words "North Haven Sons and Daughters of Italy Lodge 2805" in any form or order can be sold or displayed anywhere. Vendor shall not assign, sublease, apportion, mortgage, pledge or in any way transfer in whole or in part this agreement or any part of its space there under without the express written permission of Car Show Committee. No Vendor shall display, sell, or wear any items bearing offensive words or graphics, nor display such in their behavior during Car Show hours. Vendors cannot display, sell or wear any items, which imply or promote political parties, racial slogans, violence, or criminal acts. No Knives, Guns, Boomerangs, Slingshots, Swords or weapons of any kind being real or fake can be sold or displayed. No sex or drug-oriented items, sprays, noisy items, inflatable toys, or confetti eggs can be sold or displayed. No throwing of ANY object is allowed.

The NHSDI Lodge 2805 have the right to decline, prohibit or expel any Vendor, Vendor Products, Vendor Employees or Representatives, which in their sole judgment is or will be unsuitable to the character of this Car Show or endangers others. All spaces must be manned at all times.

The North Haven Sons and Daughters of Italy Lodge 2805 RESERVE THE ABSOLUTE RIGHT TO MAKE ANY CHANGES necessary to ensure the safety of anyone and everyone. These changes can/will include an immediate shut down if deemed necessary, and/or any changes in the size or duration of the Car Show due to an Act of God, or any Emergency. In the unlikely event this should happen Food vendors who are using a method of cooking or power, <u>MUST</u> IMMEDIATELY! Shut down or extinguish any and all methods of cooking or power.

We also reserve the right to settle any dispute of any kind concerning Car Show, and to interpret the terms of this agreement, to recover any reasonable ATTORNEYS FEES and North Haven Sons and Daughters of Italy Lodge 2805 Fees in connection with any dispute arising under this Agreement.

**NO ALCOHOLIC BEVERAGES** of any kind shall be displayed, sold or consumed by Vendor or Vendors employees or representatives within the leased space or anywhere on Car Show Grounds. No pets are allowed any place on Car Show grounds

No Smoking is allowed in or around any food booths. Also, please do not smoke on Car Show Grounds.

FAILURE TO COMPLY with any of the North Haven Sons and Daughters of Italy Lodge 2805 guidelines or conditions either contained herein or later provided to Vendor either orally or in writing, shall be grounds for immediate TERMINATION of this agreement with NO REFUND to Vendor.

#### **SET-UP & REMOVAL:**

Setup of your space can begin, August 6, 2022 at 7am. IMPORTANT! When you arrive, please seek out a Car Show Committee representative for instructions on where you are required to set up and Tent approval. DO NOT SETUP WITHOUT A CAR SHOW REPRESENTATIVE'S APPROVAL. Setup must be completed by 9:00am, August 6, 2022. The Car Show begins at 9:00 am. Vendors must supply tables, chairs, and equipment for their space. Vendor must at all times be able to supply the products, items, or services in this Agreement. Failure to do this may result in loss of Security Deposit. No vendor is allowed to deface Church Property, the Parking Lot or the Grass areas in any way. Please do not anchor or affix anything to pavement. Tents may be anchored via Water tubs or weights. Tent anchor must not cause any safety hazard. Vendor's will not under any circumstance block or obstruct any other vendor's space. Vendor must remain open until Car Show end at 3pm. All vendors are responsible for maintaining rented space in a manner that is both safe and pleasing to their workers and customers at all times. All trash must be bagged continuously and placed in the proper area. You will be informed of the proper procedure at set up time. No liquid waste of any kind can be discharged on the grounds. Vendors are responsible for removing their own property and cleaning their own space at the close of the Car Show. Vendor shall surrender premises in clean condition or the \$25.00 Security Deposit will not be refunded.

Vendor applicant acknowledges having read and understood the terms and conditions of this agreement herein this document. The Vendor agrees that if accepted as a Vendor at this event, to abide by all terms, conditions and regulations as set forth in this agreement, as well as any new or additional regulations which may be modified or later required by NORTH HAVEN SONS AND DAUGHTERS OF ITALY LODGE 2805 or any of their designated representatives. Applicant must be 21 years of age and have the authority to execute this Agreement. If Agreement is approved a copy signed by Lodge President will be returned. If Agreement is not approved all your payment will be returned.
