*Resolution 2025-07 - A Resolution Allocating Infrastructure Funding from Sherman County FY 25-26* was reviewed. A motion was made to approve Resolution 2025-07 as presented **(Anderson/ West) the motion carried.**

*Resolution 2025-08- A Resolution authorizing signers for Moro Cemetery Annuity with Nationwide* was reviewed. A motion was made to approve Resolution 2025-08 as presented. **(Anderson/ West) the motion carried.**
