### Ordinance 7-22-2020

#### ORDINANCE AMENDING ARTICLE V, SECTION (A)

AN ORDINANCE AMENDING CITY OF DRAKESBORO CODE OF ORDINANCES 06-27-18, ALCOHOLIC BEVERAGE CONTROL, SPECIFICALLY ARTICLE V, SECTION (A) IN ORDER TO INCLUDE SUNDAY HOURS FOR SALE AND DELIVERY UNDER THESE SECTIONS.

WHEREAS, the City of Drakesboro desired to amend Article V, Section (A), Hours of Sale to include Sunday hours for sale of alcoholic beverages.

WHEREAS, the Drakesboro City Council has reviewed and discussed the following proposed changes to ARTICLE V, Section (A) of the City of Drakesboro Code of Ordinance and believe are reasonable and necessary.

BE IT ORDAINED by the City Council of the City of Drakesboro, as follows:

AMENDMENT 1. ADDITIONS, ASSERTIONS, AND CHANGES:

ARTICLE V, SECTION (A) is amended to read in its entirety as follows:

A. A licensee for distilled spirits, wine, or malt beverages, shall be permitted to sell or dispense distilled spirits, wine, and/or malt beverages between the hours of 6:00 a.m. (CST) and 12:00 (Midnight) (CST) Monday through Saturday. ~~No Sunday Sales permitted.~~ A licensee for distilled spirits wine, or malt beverages shall be permitted to sell dispense distilled spirits, wine, and/or malt beverages on Sunday between the hours of 11:00 a.m. (CST) and 10:00 p.m. (CST) in accordance with KRS 244.290 (4).

B. Quota retail drink (tavern) establishments shall be allowed to serve alcohol drinks from 6:00 a.m. (CST) to 12:00 (midnight) (CST) Monday through Saturday. ~~No Sunday Sales permitted.~~ Quota retail drink (tavern) establishments shall be allowed to serve alcohol drinks on Sunday between 11:00 a.m. (CST) and 12:00 (midnight) (CST) in accordance with KRS 224.290(4).

C. A special Sunday retail alcohol license must be purchased in the amount of \$300.00 per year in accordance with KRS 243.070(1)(k).

Nothing in this Ordinance hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any case or causes of action acquired or existing under and/or ordinance hereby repealed as cited in this Ordinance; nor shall any just or legal

right or remedy of any character be lost, impaired, or affected by this Ordinance.

All other sections and provisions of the Ordinances for the City of Drakesboro, not specifically amended herein, shall remain in full force and effect and shall not be considered amended and shall be incorporated by reference as if fully stated herein.

This ordinance shall take effect immediately after its passage and publications as required by law.
