MINUTES OF THE SPECIAL GENERAL BODY MEETING OF THE NEW SUJATA CO – OPERATIVE HOUSING SOCIETY LTD HELD ON 28th OCTOBER 2023, 6.30 PM IN THE SOCIETY PREMISES.

Mr. T.Venkataramani, Treasurer explained the procedure for accessing various documents uploaded in the Society's website "newsujata.com". All members were requested to go through the profiles /presentations of the six Project Management Consultants (PMCs) which are uploaded in the website under documentation. It was also requested that members may shortlist 3 PMCs and send their names by email or letter to the society office before 17.11.2023.

After receiving the shortlisted names of the 3 PMCs from members, presentation by the 3 PMCs with maximum count will be arranged at a convenient date and time for all the members.
