**VENDOR INFORMATION**

All exhibitor sites are located outside, Space is limited and will be awarded on a first come first serve basis. Upon receipt of your form and payment you will be notified of your acceptance. There is limited shade and you are encouraged to bring a canopy.

Each vendor will have a 10'x10' space on the grounds of Green Gables.  
No parking on the premises. Free parking will be next door (North) at Reflections.  
Vendors must provide their own canopies, tables and chairs.  
All canopies must be securely fastened and anchored to the ground.  
No electricity is available.

Vendors will have 15 minutes to come on the premises, unload their vehicle, move the vehicle to the parking area, then return to their site to setup. Volunteers will be available to help you unload your vehicle.

Unloading will begin at 7:00am. All vehicles except food trucks must be off the premises by 8:45am. Set up times are not being assigned this year, but remember there will be congestion and patience will be required during unloading and setup.

The festival will run from 9 am to 3 pm. In consideration of guests and other vendors please do not breakdown your setup before 3 pm.

There will be a numbered stake at each assigned site and a volunteer to guide you to your location. In addition to this information sheet you will be receiving a map showing your location and a vendor list with your name and site number. You should receive this information by September 18.

Green Gables assumes no responsibility for loss or damage of property, personal injury or any other liability. Vendors assume full responsibility for insurance, taxes and complying with all state and local laws.
