- <u>All deposits</u> are <u>non-refundable</u> and due at time of booking to secure date.
- Deposits are applied to booking total.
- In the event that a booking can not be fulfilled on the day scheduled due to inclement weather or an unforeseen emergency the deposit can be held to reschedule for a later date/time up to six months from original date.
- All remaining charges will be due prior to scheduled date as follows: For in house Birthdays during normal business hours for play due at least 72Hrs prior, After hour play parties due at least one week prior, for larger Events and Bookings that will require normal business hours to be adjusted or closed such as Receptions, Showers, Shows, Dances, Company Events, etc. due one month prior.
- All parties or venue space bookings must be cleared of all decorations, linens, covers and personal property by conclusion of event time.
- All trash must be placed in designated bins by conclusion of event time.
- Snacks and Beverages are available for purchase.
- Outside Food and Drinks are allowed.
- <u>No alcoholic</u> beverages allowed on the premises <u>unless hired bar</u> <u>service</u> from our venue for larger events.
- <u>No</u> party poppers, confetti, piñatas, sparklers, rice, silly string, glitter, fireworks, sand or any other small particle decorations

- allowed in any area of the venue. If you are unsure of an item, consult scheduler/business owner to verify before use.
- No pets are allowed inside the venue space.
- Birthdays during normal business hours for play and after hour play parties are allowed to arrive 30min prior to scheduled start time to begin decorations and setup.
- Larger events are allowed up to 12Hrs total for booking. That does include decorations and setup time.
- All large events must conclude no later than 11pm.
- All caterers hired for larger events must be <u>full service</u>. They must bring all materials needed for their service. They must stay from beginning to end, clean up tables of all food/beverages and any spills that may occur. All trash bins must be emptied and taken to outside dumpster on-site at the conclusion of their service.
- Additional charges may be required for any damages that may occur to venue space or provided venue property.
