Privacy Policy

This Privacy Policy ("Policy") applies to Air Neuro Inc. ("The Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include airneuro.com. The Company's website is an accounting audit and assurance financial website. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:
