**CONDUCT POLICY:** Any participant whose conduct is deemed to be unsportsmanlike shall be subject to suspension, possible loss of points and monies, and ejection from the grounds. Unsportsmanlike behavior (directed toward track officials, workers, other participants, fans, spectators, or sponsors) shall include but not be limited to: fighting, harassing, abusive behavior, angry outbursts, obscene language or gestures, as well as speeding in the pits. The length of the suspension will be determined by track management and is non-appealable. Violators may also be subject to criminal prosecution or civil suit. If police intervention is required, you will be suspended for a year to the day. Any person suspended for violation of the conduct policy will be prohibited from entering an ISS event for the duration of the suspension. Quite simply, this means you will not even be allowed to come spectate! We are expected to conduct ourselves as professionals. Those who cannot will not be allowed to participate in any of our functions.

**ON TRACK POLICY:** Any Driver who's driving is deemed reckless by ISS or track officials, will be black-flagged and removed from the race. Should the reckless manner be deemed intentional, the track may issue a suspension.

**CREW RESPONSIBILITIES:** Drivers and owners be warned! You are responsible for the actions of your crew. Crew members in violation of the conduct policy could possibly subject the entire team to suspension. Choose your crews wisely!!

**ALCOHOL POLICY:** I understand the ISS has a "Zero Tolerance" alcohol policy by any participant whom would enter the pit area.

**CONTRACT:** I hereby certify that I am an independent contractor, assuming all responsibility for monies received as a result of my activities at ISS, including without eliminating, income taxes, FICA, worker's compensation and withholding taxes. I am not an employee, servant or agent of the ISS.

**CONSIDERATION AND COMPLIANCE:** In consideration of acceptance by the ISS of this application and payment of membership fees and/or pit entrance fees, the undersigned agrees to abide by all rules and regulations of the ISS as to conduct and mechanical specifications, as now published or hereafter modified. Undersigned further recognizes his obligation to the public and the ISS, which posts the prize monies and conducts the events, and agrees to compete in all events for which he may be qualified, if humanly possible.

**BREACH AND DAMAGE:** In the event the undersigned breaches this agreement, he shall be liable for actual and liquidated damages sustained by the ISS as a direct or indirect result of such breach.

**BENEFITS:** I understand and agree that myself and my executors and assigns will be entitled to benefits of the accident insurance policy procured by the ISS for accidental injuries or death which occur as the result of external, violent and visible means, sustained in ISS events. The coverage of said policy shall constitute the limit of liability of the ISS for such injuries occurring to me in any ISS event, provided proper notification of such occurrence is filed with the ISS.

**OWNERSHIP:** If owner of a registered racing car, I hereby certify that I have good and marketable title to said vehicle or any part thereof, in the event same is claimed or sold pursuant to the rules of the ISS.

**ACCIDENTS:** If any participant or spectator should be seriously or fatally injured, the ISS reserves the right to impound the involved car(s) for review and evaluation, and may exercise this right at any time. Furthermore, if it becomes necessary to, in the opinion of the ISS personnel or safety crew, cut the car apart the ISS reserves the right to do so in any manner they see fit without incurring any obligation whatsoever.

**ADVERTISING RELEASE:** The undersigned consents to the use of his name and/or pictures of himself and his car, for publicity, advertising and endorsements, both before and after events, and relinquishes any rights to photos taken in connection with events, and consents to the publication or sale of such photos by the ISS.

**ARBITRATION:** Any dispute, controversy or claim involving the undersigned member, whether or not relating to this agreement or alleged breach of same, shall be settled in accordance with the existing and/or emended rules and regulations of the ISS, and the undersigned agrees that these decisions are non-litigable.

**COVENANT NOT TO SUE:** All participants further covenant and agree that they will not initiate any type of legal action against the ISS and its employees, to challenge such decisions, to seek money damages, to seek injunctive relief or to seek any other kind of legal remedy. If a participant pursues any such legal action, which violates this provision, then the participant expressly agrees to reimburse the ISS for all of its attorney's fees and costs in defending against such legal action.
