John will forward the cancellation to the Treasurer for a refund (less \$5). **Please note:**

Cancellation within 24 hours of a tournament date will result in the forfeiture of the green fee.

OLD GOAT CUP COMPETITION

Points are based on the top 20 players by net score in each flight. The player with the best net score in each flight will get 20 points. The 2nd best net score will get 19 points and so on down to the 20th place, which will get 1 point. Points will be accumulated even if you play in more than one flight. Your final point total will be based on the flight most played, but will also include all points from the other flights played. The two-day "over-night" tournaments will not be included. This year, like last, there will be twelve tournaments included in the Old Goat Cup. See the IESGA website or your tournament business card for the qualifying tournaments. Players will be awarded double points for the two-day club championship. If you missed a couple of regular tournaments during the year, points could be made up in the championship play. Payouts for each flight is on a percentage basis depending how many entrants are in each flight. Each flight will receive cash payouts at the end of the year. The first-place player in each flight will also receive a Trophy. There is a one-time entry fee of \$25 to participate in this competition and it must be paid on or before June 12, 2020. In other words, you can't do well in a tournament and then decide to get into the Old Goat Cup after the fact. Again, this is a voluntary competition. It is separate from the other games: skins, deuce pot, honey pot, net score, etc. To participate, fill out the entry form, cut it off and send it in. The IESGA adds \$1,000 to the payoff.
