### **EXECUTIVE SESSION**

The Board of Directors reviewed the September legal status report, and no action was needed.

The Board of Directors reviewed the aging report, and no action was taken.

The Board of Directors discussed an unapproved property improvement and approved to escalate account directly to the attorney for further escalation. They also reviewed and approved the letter drafted by the HOA attorney to be sent to the homeowner. Motion to approve – Robert, Second – Alfred, 5-0

The Board of Directors discussed the counteroffer for the small piece of land by old Tucker Road and decided to make a counter offer back of \$4,000.

# **GENERAL BUSINESS**

# Action taken since last board meeting:

- Tex Scape proposal for irrigation repair on west side of South Shore Blvd to support the revamp of the east side irrigation system in the amount of \$1,461.38.

**Holiday Decorations:** The Board of Directors reviewed the proposal from Tis the Season and approved to move forward with a 3-year contract in the amount of \$20,686.03 per year. Motion to approve – Robert, Second – Valerie, 5-0

**Hurricane Beryl Damage:** The Community Manager, Linda provided the homeowners in attendance with an update on the repairs caused by hurricane Beryl.

Insurance check has been received and all work except for the roof replacement at the pool and playground pavilion have been completed. Roof replacement is scheduled for October after the pool closes for the season. The board has not determined the shingle color and requested samples to review before making a final decision.

# **Landscaping/Irrigation:**

Landscaping: The Board of Directors reviewed a proposal to enhance the intersection of Island Crossing and South Shore Blvd. area and requested that the proposal be sent to the landscape committee for further review with Tex Scape.

Irrigation: The following update was provided: The previously approved irrigation revamp on the east side of South Shore Blvd is currently being done.

**Playground**: The Board of Directors reviewed the McKenna Contracting proposal which included upgrades and repairs at all 4 playgrounds and approved to move forward with all listed except the ADA items in the amount of \$35,193. Motion to approve – Robert, Second – Valerie, 5-0
