GENERAL BUSINESS

Annual Meeting

Tree Trimming Proposals:

The Board of Directors were presented with 2 proposals for tree trimming. The Board approved to move forward with proposal 1048668 totaling \$2801.43.

Fountain Replacement:

The Board of Directors reviewed proposals for fountain replacements from Danbury and Lake Management. They requested that Lake Management be approached to see if they could better align their pricing with that of Danbury before a decision is made.

Board Candidate Introductions:

Catherine Grant and Jeff Young introduced themselves to the Board of Directors and homeowners.

Reserve Study:

The Board of Directors reviewed 3 proposals for a community reserve study. The Board of Directors and approved to move forward with Reserve Advisors.

Irrigation Repair Proposals:

The Board of Directors viewed 3 proposals from TexScapes for repairs needed to the irrigation system. They approved proposal #40348 for \$3729.21 to repair controller 2, proposal #40347 for \$2381.50 to repair controller 1, and proposal #40349 totaling \$2549.29 to repair controller 3.

MUD UPDATE:

Mr. Day provided an update on the Austin Lake bulkhead project and other MUD related topics. The MUD Board approved the check from the irrigation issues. He confirmed that the bench that was damaged during construction on Austin Lake was in the process of being replaced. The MUD Board will be doing another walk with the contractors before everything wraps up within a month.

HOMEOWNER FORUM:

A homeowner brought up concerns about wildlife access in Ausin Lake as well as mosquito control concerns at Tucker Lake. Another homeowner brough up concerns about the need for landscape enhancements and when that would be going in and brought up the signage around Austin Lakes and whether or not that would be replaced at Fresh Wind/Cayman Bend.
