#### **FINANCIALS**

The financial report was provided to the membership including various charts and graphs presenting year ending results for the 2020-21 fiscal year and bank account balances for all Association accounts. The approved budget for the 2021-22 fiscal year was also reviewed with the membership.

## STATE OF THE ASSOCIATION
