#### **AGENDA APPROVAL**

The Board reviewed the agenda and a motion was made to add pressure washing of the cement fencing and playground maintenance at the beginning of new business as items 6 and 7. Motion- Rob, Seconded- Mike, motion passes 3-2

- The requested addendum to discuss the special meeting was rejected by a 3-2 vote.
- A meeting to discuss the Special Meeting request has been previously scheduled with Spectrum, association counsel and the Board.

Items B & E were ratified without exception and actions were indeed properly executed by the board. Motion Rob, Second- Mike, motion passes 3-2

- Motion to approve Sixth Man \$2500 bid to pressure wash all of the existing concrete fencing in the community. Motion Allison, Second- Mike, motion passes 4-1
- Motion to have all of the playgrounds inspected, to have inspections completed annually, and to approve up to \$10,000 for repairs. Motion Claudia, Second Mike, motion passes 5-0
- Motion to take up the fence resolution in the board packet for discussion. Motion- Rob, second-Claudia
  - Motion to adopt the fencing resolution as presented that transparently and plainly specifies
    fencing under our associations ownership and maintenance responsibility across the
    community with edits to remove fencing along Columbia Memorial Parkway, Brook Arbor and
    the commercial area that are not currently specified under association management. Motion
    Rob, motion fails
  - Motion to table the fencing resolution pending further discussion, revisions, implications, and reparations of ownership. During this time if there are any homeowners that have repairs needed to their fence that are the responsibility of the association, they should contact Spectrum AM so that a vendor can evaluate. This policy will be discussed and ready for the next board meeting. Motion Claudia, Second Allison, motion passes 5-0

  information will be added to Facebook, website and e-blast
