FINANCIALS

The board and homeowners were presented with the financials for September 2022.

OLD BUSINESS

- Actions between meetings: The Board approved the invoice from McWilliams Electric in the amount of \$3580.00 for the work needed to install the card access device system. The Board also approved the new proposal amount of \$15, 745 plus tax from Southern Technologies. This increase was from adding a weatherproof power encloser and self-closing hinges on the pool and tennis court gates.
 Landscape Advisory Committee: Richard mentioned he didn't have an update at this time, and he would be planning a meeting in the upcoming future. A request was made for the LAC to provide feedback on trimming the crepe myrtles.
- **Tennis Court Repairs:** An update was provided on the card access device system being installed and the distribution of the cards to homeowners. The access device will be installed in the next few weeks and communication will be sent out once complete.
- **MUD/Lakes:** The Board of Directors reviewed two proposals for one of the lake fountains and approved to replace the entire unit in the amount of \$3,431.27. Motion to approve Vikki, Second Melanie, 3-0. In addition, an update was provided from Melanie and Linda attending the MUD meeting earlier in the day. The MUD will be preforming a preliminary survey of the perimeter of the lake to determine the linear feet and start working on gathering proposals to install a perimeter fence.
- Events: The next event is scheduled for December 10th Neighborhood Christmas Event from 10 a.m.
 12 a.m. The event will have cookies, hot chocolate, Santa, and a foam party.
