

MEMBERSHIP AGREEMENT

The following makes up the overall Membership Agreement between Sisters Pickleball Club (SPC) and the member.

Membership Details

- Annual club membership term runs from April 1 until the following March 31st.
- Membership is open to anyone 16 years and older.
- Membership fee is \$100/person/term - whenever you sign up. Fee will not be prorated.
- Memberships will automatically renew with reminders sent 30 days prior to April 1st each year.
- Members can "Opt-in" to store payment information and have their membership renewals automatically paid.
- Members can cancel anytime. No refunds will be given but the member will still have access to the club's courts and sessions for remainder of their current term.

Guest Access

- Only members may reserve a court but they can invite guests to join them as long as the guest pays the appropriate guest/non-member fee.
- Non-members can join an event (organized play session) by paying the guest fee.
- SPC may limit the number of times a player can access SPC courts/events as a guest
- All guests must sign a Waiver of Liability and adhere to all terms and conditions of Guest Membership agreement.

Sisters Park and Recreation District rules

All members and guests must comply with SPRD's park rules while on park property. SPRD does not allow dogs at Pineview Courts.

Club By-Laws

All members are governed by the current By-laws for Sisters Pickleball Club, Inc. which can be found on [Club's website](#).

Code of Conduct

All members and guests are required to comply with Sisters Pickleball Club's Code of Conduct, which can be found on [Club's website](#).

Waiver

All new members must sign a Waiver of Liability. Members who are under 18 must have a parent or legal guardian sign the waiver for them.

Damages

Members and guests agree and shall pay for any damages to the equipment or premises resulting from you or your guest's improper use, violation of rules, or misconduct.

Termination Policy

Sisters Pickleball Club reserves the right to terminate a membership for violation of our policies. The Club's Board will determine if a violation has occurred. Depending on the type of violation, the Board has the sole discretion to offer warning(s) prior to termination or simply terminate the membership. The termination will be done in writing via email and, if a mailing

address is available, via postal service. No refund will be provided for any terminated membership.

Cancellation and Closure Policy

- Sisters Pickleball Club reserves the right to cancel any organized play and close courts for reasons including, but not limited to, weather, natural disasters or other emergencies.
- Sisters Pickleball Club reserves the right to close courts from member reservations due to Club events or SPRD events (based on operating agreements with SPRD.)

Changes

Sisters Pickleball Club reserves the right to make changes to this overall Membership Agreement at any time without notice.

Miscellaneous

By signing this Membership Agreement, you represent, or acknowledge and agree (as the case may be), that:

- You have the authority to bind yourself to the terms and provisions of this Membership Agreement;
- You will promptly notify Sisters Pickleball Club of any changes in your membership information;
- You are an authorized user of and have the authority to use the credit card or other payment method used to purchase the membership, and you will not dispute the scheduled transactions with your bank or credit card company so long as the amounts charged are in accordance with the provisions of this Membership Agreement.
