There will also be opportunities to excavate and to work in the lab, so be sure to register for the TAS Field School as soon as possible.

With regard to a survey of a different type, we received 5 responses to our NTAS member survey at the March 14 meeting. An additional response was received by email. Blank forms will again be available at the April 11 meeting.

April Speaker: Doug Boyd

Ethnic Identity at Frost Town: Archeological Investigation of German, African American, and Mexican Heritage of a Historic Urban Community in Houston, Texas

Beginning in the 1830s, German immigrants settled in a prominent bend of Buffalo Bayou located just downstream from Allen's Landing. Known as Frost Town, this 8-block area evolved into a thriving Houston neighborhood that survived for more than 120 years. The ethnic makeup of the community changed over time, and occupation periods are identified by dominant groups that lived there as: German Period from 1830s–1890; African American Period from 1890–1920; and Mexican/Mexican American Period from 1920–1955. Located in the shadow of downtown Houston, and only a few blocks north of the Houston Astro's ballpark, Frost Town was one of Houston's oldest neighborhoods. As modern developments engulfed the area, the *Barrio del Alacran* (as the neighborhood was called by the twentieth-century Hispanic residents) was slowly abandoned between the mid 1950s and the 1990s. Now reduced to archeological remains, Frost Town is one of the least known, yet most important, historic sites in the city of Houston.



Intermittently since 2004, Prewitt and Associates, Inc. has conducted archival research, oral history interviews, and several phases of archeological survey and excavation at the historic Frost Town site (41HR982). A Texas Department of Transportation road improvement project triggered these historic archeological investigations. In 2016 and 2018, PAI archeologists conducted intensive archeological data recovery investigations at the site, collaborating with TxDOT's Archeological Studies Program and many volunteers from the Houston Archeological Society. This work discovered over 1400 features and more than 200,000 artifacts representing all three occupation periods. The analysis of the features and material remains is underway.

This program is a preliminary look at some of the historical and archeological evidence for the ethnicity of Frost Town residents, and it will highlight some analytical challenges that lie ahead. The features and artifacts reveal some exciting insights into the people who lived in Frost Town. Among the more unusual types of features are two "ornamental bottle alignments"—rows of buried, upside-down glass and ceramic bottles. Archival and oral history research reveals that these alignments are decorative borders along gardens and walkways, and they represent a strong tradition among nineteenth-century German immigrants in Texas. Many of the artifacts—such as German-made dolls, various products made and sold by local German merchants, and hand-painted Mexican pottery—reveal the ethnic heritage of specific Frost Town residents. In addition, we will explore the mystery of the Chinese opium pipe bowl recovered from one of the Frost Town trash pits.

Doug Boyd

Boyd received a BA degree in General Studies-Archeology from West Texas State University in 1982 and an MA degree in Anthropology from Texas A&M University in 1986. He joined Prewitt and Associates, Inc., in 1987, and is a vice president of the firm. Boyd is active in the Texas Archeological Society, and currently serves as the TAS representative on the Texas Historical Commission's Antiquities Advisory Board and is a co-director for the Youth Group at the annual TAS field school.

In the past 35 years, he has participated in or directed many archeological projects in Texas, Oklahoma, and New Mexico, including investigations at a wide range of prehistoric and historic sites and published numerous reports and articles. His historic site investigations include cemeteries, Anglo ranching sites, Spanish Colonial sites, African-American farmsteads, Hispanic townsites, brick kilns, and antebellum plantations. Recently, he was the primary contributor to an elaborate historical archeology exhibit on the *Texas Beyond History* web site called: "Life After Slavery: Investigations of an African American Farmstead." Currently, Boyd is the principal investigator for the Frost Town Archeological Project, a major data recovery excavation of a historic urban community near downtown Houston. This project is being done in conjunction with a Texas Department of Transportation road project.



NTAS meets at 7:30 p.m. on the second Thursday of each month (except June and December) at the University of North Texas Health Science Center, 3500 Camp Bowie Boulevard, Fort Worth (in the Lewis Library Building, Room 110), near the intersection of Camp Bowie and Montgomery Street.
