February 8 was a cloudy, cold, damp day. But, for two and a half hours, I forgot (or at least overlooked) the cold, spellbound by the remarks of Dr.

Thomas Williams, Assistant Executive Director of the Gault School of Archaeological Research, as he led a stimulating, informative and enjoyable tour of the Gault Site. Thanks to Tom's lively and enthusiastic explanations of the many areas of the site, I was able to visualize the people and the numerous activities they performed along this section of Buttermilk Creek during the Middle and Late Archaic periods, the Clovis period, and the pre-Clovis period. Like the other 37 NTAS members on the tour, I came away with a much deeper appreciation for the Gault Site and for the peoples who lived there during at least 16,000 years of Texas history and pre-history.

On behalf of NTAS, I really want to thank Tom Williams for the outstanding tour, for freely sharing his expertise with us, for his in-depth explanations, and for his thorough answers to our many questions. Everyone on the tour agreed that the visit was time well spent.

Of course, this was not the first time that many of us had heard Tom Williams discuss the Gault Site and Texas' very early pre-history. He was the Public Forum speaker at the 2017 TAS Annual Meeting in Grapevine. For those of us who heard "The Deeper We Dig, the More Questions Arise", the number

March Speaker: Tiffany Osburn

An Introduction to the 2020 TAS Field School in Kerrville, Texas: Hill Country Archeology at Its Best

This year, the Texas Archeological Society (TAS) invites members to attend the annual summer Field School along the banks of the Guadalupe River in Kerr County. Kerrville offers much to visitors year-round and will be the ideal location for the upcoming field school. TAS is being welcomed with open arms by the Hill Country Archeological Association, the City of Kerrville as well as Kerr County. The subjects of archeological investigation are rich this year. This presentation will summarize the archeological sites where we will be working, previous work conducted on this terrace of the Guadalupe River, research goals for the field school, and all of the other activities that will be offered to participants. The dates for the 2020 Field School will be June 13-20.


Tiffany Osburn serves as the Regional Archeologist for central and west Texas with the Texas Historical Commission (THC) where she is focused on the preservation of historic Texas landscapes. In her current role with the state she has the privilege of working with private landowners and communities to record and preserve important places in Texas for future generations. In addition, as a project reviewer for state and federal compliance under preservation law, she balances the development needs of Texas with our responsibility to retain the significant historic character of our state. Prior to joining the THC, Tiffany earned a Master's Degree from the University of Denver where she conducted archeological research with a specialization in near-surface geophysics and worked for 10 years in the private sectors of cultural resource management and environmental compliance. Tiffany focuses her career on responsible stewardship of archeological resources and land conservation as a means of preserving our heritage.



NTAS Monthly Meeting Location & Directions

NTAS meets at 7:30 p.m. on the second Thursday of each month (except June and December) at the University of North Texas Health Science Center, 3500 Camp Bowie Boulevard, Fort Worth (**in the Research and Education Building, Room 114**), near the intersection of Camp Bowie and Montgomery Street.

Traveling west on I-30 from downtown, take the Montgomery Street exit. Turn right on Montgomery and continue to the five-way intersection at Camp Bowie. TAS Ceramics Academy

When: March 28-29, 2020

Where: Fort Concho National Historic Landmark

Cost: \$100 (and TAS membership)

TAS Archeology 101 Academy

When: May 1-3, 2020

Where: San Felipe de Austin State Historic Site

This three-day Texas Archeology Academy introduces the field of archeology and provides each participant with the tools to identify, assess, and record an archeological site. Instruction will include identifying archeological sites, mapping visible remains, analyzing evidence, reporting finds, and protecting our heritage from destruction. This Academy will include instruction and laboratory exercises led by Dr. Jon Lohse and a day of field excavations at San Felipe de Austin State Historic Site. Dr. Sarah Chesney, archeologist at the San Felipe de Austin State Historic Site will be the Principal Investigator for Sunday's excavations.
