SECTION II - GENERAL RULES AND REGULATIONS

ITEM 1

GOVERNING RULE FOR TARIFF 50-T PARTICIPANTS

This rule is only applicable to movers participating in Tristate Household Goods Tariff Conference, Inc., Agent, Tariff Freight Pa. P.U.C. No. 50, supplements thereto and successive issues thereof, a time basis tariff applying on shipments of household goods and related articles, in use, transported distances of 40 miles or less.

Listed below are explanations on the proper method of applying transportation rates for shipments transported under Tariff Freight Pa. P.U.C. No. 50.

(1) Participants may elect to assess hourly rates based on Rate Tables for the county in which the participant is domiciled (except as provided in Paragraph (3) below).

OR

(2) Participants may elect to assess higher hourly rates for shipments originating in the county in which the participant is domiciled by taking exception to the Rate Tables applicable for the county in which the participant is domiciled (except as provided in Paragraph (3) below).

(3) When a Shipment is picked up in a county which published higher hourly rates than the rates that would have been assessed under application of Paragraphs (1) or (2) above, participant must charge the higher hourly rates based on the Governing Rate Tables dependent upon the county in which shipment is originating.

(4) When a shipment is picked up in a county which published lower hourly rates than the rates that would have been assessed under application of Paragraphs (1) or (2) above, participant must assess hourly rates based on the use of Paragraphs (1) or (2) above, whichever applicable .

SECTION II - GENERAL RULES AND REGULATIONS

ITEM 3 COMMODITY DESCRIPTION AND CLASSIFICATION OF PROPERTY

The classification of property to which these rates, rules and regulations apply is that class of property designated by the Pennsylvania Public Utility Commission in Released Valuation Rate Docket No. 46.

All property transported under the commodity description as set forth above shall be subject to the following classification and minimum weights and rates as set forth herein.

▲ CLASSIFICATION OF PROPERTY

FIRST PROVISIO (CLASS 1 SHIPMENTS)

(1) Personal effects and property used or to be used in a dwelling when a part of the equipment or supply of such dwelling and such other similar property; except that this subparagraph shall not be construed to include property moving from a factory or store, except such property as the householder has purchased with the intent to use in his dwelling and which is transported at the request of, and the transportation charges paid to the carrier by, the householder;

SECOND PROVISIO (CLASS 2 SHIPMENTS)

(2) Furniture, fixtures, equipment and the property of stores, offices, museums, institutions, hospitals or other establishments when a part of the stock, equipment, or supply of such stores, offices, museums, institutions, hospitals, or other establishments; except that this subparagraph shall not be construed to include the stock-in-trade of any establishment, whether consignor or consignee except when transported as incidental to moving of the establishment, or a portion thereof, from one location to another;

THIRD PROVISIO

(3) Articles, including objects of arts, displays, and exhibits, which because of their unusual nature or value require specialized handling and equipment usually employed in moving household goods; except that this subparagraph shall not be construed to include any article whether crated or uncrated, which does not, because of the unusual nature or value require the specialized handling and equipment usually employed in moving household goods.

APPLICABILITY - - DEFINITION OF TERM "40 MILES OR LESS"

The rates, rules and regulations named herein shall apply to shipments:

- (a) Where there is only one point of origin and one point of destination and the distance between such points is 40 miles or less; or
- (b) Where there is more than one point of origin or destination, or both, and the distance between first point of origin and final point of destination is 40 miles or less.
(Where, on shipments with more than one point of origin or destination, or both, the distance between first point of origin and final destination is more than 40 miles, rates for transportation of the entire shipment shall be computed from carriers' tariffs applicable for distances of more than 40 miles.)

SECTION II - GENERAL RULES AND REGULATIONS

RULE 1 - Property Subject to Uniform Household Goods Bill of Lading

- ▲ (a) Unless otherwise provided, when property is transported subject to this commodity classification, the acceptance and the use of the Uniform Household Goods Bill of Lading is required.
- (b) The rates shown herein are reduced rates conditioned upon the use of the Uniform Household Goods Bill of Lading. Consignor, at his option, may elect not to accept the terms of the Uniform Household Goods Bill of Lading, and in lieu thereof to have the carrier transport the property with carrier's liability limited only as provided by common law and by the laws of the United States and the several states insofar as they apply, but subject to the terms and conditions of the Uniform Household Goods Bill of Lading insofar as such terms and conditions are not inconsistent with such common carrier's liability; the rate charged therefor will be 100 per cent higher than the rate and charges contained in this tariff as would otherwise apply.
- (c) When the consignor elects not to accept any of the terms of such bill of lading he must give notice to the initial carrier of such election. The initial carrier must indicate the receipt of such notice by writing or stamping thereon a clause signed by the carrier reading:

"In consideration of the higher rate charged, the property herein described will be carried, and the services to be rendered hereunder will be performed, with the carrier's liability limited only as provided by law; but sub subject to the terms and conditions of this bill of lading insofar as they are not inconsistent with such common carrier's liability."

RULE 2 - Insurance

The cost of insurance against marine risk or any insurance in the name of the shipper or for the benefit of the shipper, will not be assumed by the carrier.

<p>DECLARATION OF VALUE</p>	<p style="text-align: center;"><u>RULE 3</u></p> <p>(a) Shippers are required to state specifically, in writing, the agreed or declared value of the property.</p> <p>(b) Valuations shall be declared in accordance with Pennsylvania Public Utility Commission Released Valuation Rate Docket No. 46, except as indicated in Rule 37.</p> <p>(c) If shipper declines to declare the value or agree to a released value in writing, the shipment will not be accepted.</p> <p>(d) The agreed or declared value shall be deemed to relate to all services undertaken by the carrier or its agents, to each article separately and not the shipment as a whole. Such agreed or declared value must be entered on Bill of Lading in the following form:</p> <p style="text-align: center;">THE AGREED OR DECLARED VALUE OF THE PROPERTY IS HEREBY SPECIFICALLY STATED BY THE SHIPPER TO BE NOT EXCEEDING.....PER POUND, PER ARTICLE.</p> <p>(e) The agreed or declared value shall be stated in cents or dollars and cents per pound.</p> <p>(f) Shipper may declare, on specific articles, valuations in excess of the value declared on the shipment; such article must be described and its excess declared value set forth in space provided on Bill of Lading.</p> <p>(g) For the purposes of this rule, where weight of article lost or damaged cannot be readily ascertained such article shall be deemed to weigh not in excess of 7 pounds per cubic foot.</p> <p>▲ (h) For the purpose of this rule, rates and charges herein apply on shipments when released to a value not exceeding 60 cents per pound per article. For rates and charges to apply on shipments where declared value exceeds 60 cents per pound per article, see Item 325.</p>
<p>EXTRA PICK-UP OR DELIVERY</p>	<p style="text-align: center;"><u>RULE 4</u></p> <p>Portions of a shipment may be picked-up or delivered at more than one place enroute between origin and destination.</p>
<p>MILEAGE OR ZONES</p>	<p style="text-align: center;"><u>RULE 5</u></p> <p>(a) Where rates are based on mileage, the following shall be applicable:</p> <p>▲ 1. Except as otherwise shown herein, distance or mileage shall be that shown in Tristate Household Goods Tariff Conference, Inc., Mileage Guide No. 40, supplements thereto or successive issues thereof. RULE 6PICK-UP AND
DELIVERY AT
WAREHOUSE

- (a) Rates and charges herein do not include warehouseman's storage, labor in, labor out, or other charges of the warehouseman.
- (b) After delivery of property to warehouse (except where delivery to warehouse is for Storage-in-Transit and delivery from warehouse is made within the Storage-in-Transit period as provided in applicable tariff), property shall be subject to rules and regulations of the warehousemen.
- (c) Shipper or authorized representative shall have the right to be present during time of loading or unloading at warehouse.
- (d) On deliveries to warehouse; property shall be unloaded at door or platform, or elevator, or at other point most convenient or accessible for unloading.
- (e) Hourly rates for vehicles and men (except supervisors) apply only to men actually engaged in loading and/or unloading, and do not apply to such men while engaged in checking, tagging, marking or similar activities.
- (f) Hourly rates for vehicles and men (except supervisors) shall not continue during periods of waiting (for other vehicles to complete loading or unloading of other shipments, for use of elevator, or for any other cause); nor during periods of interruption (temporary use of elevator for other purposes, while portions of shipment are being unloaded from elevator to permit unloading of shipment, while remaining portions of shipment, or for any other cause; EXCEPT when such periods of waiting or interruption are ordered by or the fault of shipper.
- (g) When a man engages only in loading and/or unloading at warehouse (during a portion of the time or all the time vehicle is being loaded or unloaded), but does not engage in handling property at shipper's residence or establishment, hourly rates for such man shall apply only during time actually engaged in loading or unloading at warehouse.

Vehicles and men shall be deemed to have arrived at shipper's residence or establishment when they reach the nearest accessible point to such residence or establishment.

MARKING AND PACKING

RULE 8

- (a) Packages containing fragile articles or articles consisting wholly or in part of glass, when packed by the shipper or his agent, must be marked by plain and distinct letters designating the fragile character of contents.
- (b) When articles of furniture consisting wholly or in part of glass are covered or wrapped by the shipper or his agent, such articles shall be wrapped in a manner to clearly expose glass surfaces or glass portions.
- (c) When articles are improperly packed, crated or boxed and by reason thereof the contents are more susceptible to damage, mover will arrange to have such article(s) properly packed as charges as shown in Section III herein.

ARTICLES TAKEN APART PIECE OR PACKAGE ONE ARTICLE	<p style="text-align: center;"><u>RULE 9</u></p> <p>Each shipping piece or package and contents thereof shall constitute one article. The total component parts of any article taken apart or knocked down for handling or loading in vehicle shall constitute one article.</p>
ARTICLES OF HIGH OR EXTRAORDINARY VALUE NOT ACCEPTED	<p style="text-align: center;"><u>RULE 10</u></p> <p>Unless otherwise provided, the following property will not be accepted for shipment: Bank bills, coin or currency, deeds, notes, drafts, or valuable papers of any kind, jewelry, postage stamps, stamp collections, revenue stamps, letters, precious stones, or articles of peculiarly inherent or extraordinary value; precious metals or articles manufactured therefrom. Should such articles come into the possession of the carrier without his knowledge, responsibility for safe delivery will not be assumed.</p>
ARTICLES LIABLE TO DAMAGE PROPERTY	<p style="text-align: center;"><u>RULE 11</u></p> <p>(a) Explosives or dangerous goods will not be accepted for shipment. Any person or persons, whether principal or agent, shipping such goods, shall be liable for and indemnify the carrier against all loss or damage caused by such goods and carrier shall not be liable for safe delivery of the shipment.</p> <p>(b) The rates in the tariff do not obligate the carriers to receive property liable to impregnate or otherwise damage equipment or other property. Such property may be accepted and receipted for "subject to delay for suitable equipment" or for lack of sustainable equipment, may be refused.</p>
PETS, PLANTS FLOWERS, SHRUBBERY	<p style="text-align: center;"><u>RULE 12</u></p> <p>When household pets, plants, flowers or shrubbery are transported, the carrier will not be responsible for their safe delivery.</p>
INSPECTION OF PACKAGES	<p style="text-align: center;"><u>RULE 13</u></p> <p>When carrier or his agent believes it necessary that the contents of packages be inspected, he shall make or cause such inspection to be made, or require other sufficient evidence to determine the actual character of the property.</p>

RULE 18INCOMPLETE
DELIVERY

(a) When due to the size of any article or articles included in a shipment it is impossible to deliver such article or articles to the place specified by shipper within a building because of physical conditions at entrance to or within a building because of physical conditions at entrance to or within such building, such articles shall be deemed to have been delivered when placed as near the location specified by shipper as the size or shape of articles and physical conditions at entrance to or within the building will permit.

(b) If delivery by the carrier is physically impossible by reason of structure of building or its inaccessibility and shipper issues no alternate delivery instructions, the carrier shall place the shipment or any part thereof not reasonably possible to deliver, in storage to the order and at the expense of the shipper, owner or consignee of the goods, and carrier's liability shall forthwith cease and all charges then accrued shall be due and payable forthwith.

(c) Carrier will not transport such article or articles from original point of destination except at rates named in this tariff for such transportation.

RULE 19

PAYMENT

(a) The carrier will not deliver or relinquish possession of any property transported by it until all tariff rates and advanced charges thereon have been paid in cash, money order, or certified check, except where other arrangements have been made in accordance with rules and regulations of the Pennsylvania Public Utility Commission.

(b) Nothing herein shall limit the right of the carrier to require at the time of or before shipment, the prepayment in part or in full or guarantee of the charges. If upon inspection, it is ascertained that the articles shipped are not those described in the Bill of Lading, the tariff charges must be paid upon the articles actually shipped.

RULE 20

CLAIMS

(a) Any claims for loss, damage, or overcharge shall be in writing and shall be accompanied by original paid bill for transportation and original Bills of Lading, if not previously surrendered to carrier. Carrier may require certified or sworn statement of claim.

(b) Carrier should be immediately notified of all claims for concealed damage and shall be given reasonable opportunity to inspect alleged concealed damage in original package.

(c) the Carrier's liability shall not exceed the cost of repairing or replacing the property lost or damaged with materials of like kind and quality not exceeding the actual cash value of the property at time and place of loss, with due allowance for depreciation or deterioration howsoever caused, but in no event to exceed the released value declared by the shipper in accordance with Pennsylvania Public Utility Commission Released Valuation Rate Docket No. 46 of August 8, 1955, except as indicated in Rule 37.

(d) The carrier's liability for goods shall cease when the property has been delivered to and receipted for by the owner, or by the consignee or shipper or the authorized agent of either, except as to damage noted at time of delivery. When the carrier is directed to unload or deliver property (or render any services) at a place or places at which the consignee or its agent is not present, the property shall be at the risk of the owner after unloading or delivery.

RULE 20 (concluded)

(e) Where the carrier is directed to load property from (or render any services at) a place or places at which the consignor or its agent is not present, the property shall be at the risk of the owner before loading.

(f) The carrier's liability with regard to sets or matched pieces shall be limited to repair or replacement of lost or damaged piece only and shall not extend to repair, replacement or recovering of the entire set, but in no event to exceed the released value declared by the Released Valuation Rate Docket No. 46 of August 8, 1955, except as indicated in Rule 37.

(g) For the purpose of assessing carrier's liability where such liability is measured by the weight of an article and in absence of specific evidence to the contrary, the following containers and/or cartons shall be deemed to have the following weights:

FUEL COST RECOVERY CHARGE

The following Fuel Cost Recovery Surcharge will apply as follows on shipments of household goods in use, between points in Pennsylvania, transported distances of forty (40) miles and less.

- (a) The Fuel Cost Recovery Surcharge will be calculated using a "BASE PRICE PER GALLON" of \$1.267.
- (b) On the first Monday of each calendar month, the "CENTRAL ATLANTIC" average price per gallon of diesel fuel will be determined based on the price stated by the U. S. Department of Energy (DOE), Energy Information Administration (EIA) survey of "Retail-On-Highway Diesel Prices." This price will be obtained by calling the DOE Fuel Hot Line at 202-586-6966 or via the DOE Internet Website at www.eia.doe.gov.
- (c) If the first Monday of the calendar month is a federal holiday, the price will be determined based on the stated DOE price available on the next subsequent business day (Tuesday).
- (d) The DOE fuel price obtained will then become effective on the fifteenth (15th) day of the same month. The adjustment determined will apply for shipments loaded beginning on the 15th day of the month and remain in effect through the 14th day of the subsequent following month starting from the effective date of this item.

THIS PROCESS WILL CONTINUE MONTH AFTER MONTH BASED ON THE "NEW" MONTHLY FUEL COSTS.

FOR EXAMPLE

If the reported price of self-service diesel fuel determined on Monday, 10/01/2018, is \$3.447 per gallon, that amount will apply for the purpose of calculating the difference between that amount and the base price of \$1.267 per gallon for shipments loaded as of October 15, 2018 to November 14, 2018.
