**A P P L I C A B I L I T Y**

**ITEM 100**

**COMMODITY DESCRIPTION**

The description of property to which these rates, rules and regulations apply is that class of property designated by the Pennsylvania Public Utility Commission in Released Valuation Rate Docket No. 46.

**▲ CLASSIFICATION OF PROPERTY**

FIRST PROVISIO

(1) Personal effects and property used or to be used in a dwelling when a part of the equipment or supply of such dwelling and such other similar property; except that this subparagraph shall not be construed to include property moving from a factory or store, except such property as the householder has purchased with the intent to use in his dwelling and which is transported at the request of, and the transportation charges paid to the carrier by, the householder;

SECOND PROVISIO

(2) Furniture, fixtures, equipment and the property of stores, offices, museums, institutions, hospitals or other establishments when a part of the stock, equipment, or supply of such stores, offices, museums, institutions, hospitals, or other establishments; except that this subparagraph shall not be construed to include the stock-in--trade of any establishment, whether consignor or consignee except when transported as incidental to moving of the establishment, or a portion thereof, from one location to another;

THIRD PROVISIO

(3) Articles, including objects of arts, displays, and exhibits, which because of their unusual nature or value require specialized handling and equipment usually employed in moving household goods; except that this subparagraph shall not be construed to include any article whether crated or uncrated, which does not, because of the unusual nature or value require the specialized handling and equipment usually employed in moving household goods.

All property transported under the commodity description as set forth above shall be subject to minimum weight and rates as set forth in this tariff, or as amended.

**GENERAL RULES AND REGULATIONS**

**RULE 1**

**BILL OF LADING AND RATES**

- (a) Unless otherwise provided in this tariff, when property is transported subject to the provisions of this tariff, or as amended, the acceptance and the use of the Uniform Household Goods Bill of Lading is required.

If the bill of lading is issued on the order of the shipper, or his agent, in exchange or substitution for another bill of lading, the shipper's signature to the prior bill of lading as to the statement of value or otherwise, or election for common law or bill of lading liability, in or in connection with such prior bill of lading, shall be considered a part of the original bill of lading as fully as if the same were written or made in connection with the original bill of lading.

Any alteration, addition or erasure on a bill of lading which shall be made without the special notation thereon of the agent of the carrier issuing the bill of lading shall be without effect and the bill of lading shall be enforceable according to its original tenor.

- (b) The rates and charges shown herein are reduced rates conditioned upon the use of the Uniform Household Goods Bill of Lading. Consignor at his option, may elect not to accept the terms of the Uniform Household Goods Bill of Lading, and in lieu thereof to have the carrier transport the property with carrier's liability limited only as provided by common law and by the laws of the United States and the several States insofar as they apply, but subject to the terms and the conditions of the Uniform Household Goods Bill of Lading insofar as such terms and conditions are not inconsistent with such common carrier's liability; the rate charged therefor will be 100 percent higher than the transportation rate contained in this tariff as would apply for such shipment if offered for transportation at a released value not exceeding ♦60 cents per pound, per article.

When the consignor elects not to accept any of the terms of such bill of lading he must give notice to the initial carrier of such election. The initial carrier must indicate the receipt of such notice by writing or stamping thereon a clause signed by the carrier reading:

"In consideration of the higher rate charge, the property herein described will be carried, and the services to be rendered hereunder will be performed, with the carrier's liability limited only as provided by law but subject to the terms and conditions of this bill of lading insofar as they are not inconsistent with such common carrier's liability."

- (c) All rates and charges herein are dependent upon the shipment being released in accordance with the provisions of Item 3 of this tariff.

**RULE 2**

**INSURANCE**

The cost of insurance against marine risk or any other insurance for the benefit of the shipper, will not be assumed by the carrier.

---

**RULE 3**

**DECLARATION OF VALUE**

- (a) Shippers are required to state specifically, in writing, the agreed or declared value of the property.
  - ▲(b) Valuations shall be declared in accordance with Pennsylvania Public Utility Commission Final Rulemaking Amending 52, Pa. Code, Chapters 29 and 31.
  - (c) If shipper declines to declare the value or agree to a released value in writing, the shipment will not be accepted.
  - (d) The agreed or declared value shall be deemed to relate to all services undertaken by the carrier or its agents, to each article separately and not the shipment as a whole. Such agreed and declared value must be entered on Bill of Lading in the following form:  

THE AGREED OR DECLARED VALUE OF THE PROPERTY IS HEREBY SPECIFICALLY  
STATED BY THE SHIPPER TO BE NOT EXCEEDING ..... PER POUND, PER ARTICLE.
  - (e) The agreed or declared value shall be stated in cents or dollars and cents per pound.
  - (f) Shipper may declare, on specific articles, valuations in excess of the value declared on the shipment; such article must be described and its excess declared value set forth in space provided on Bill of Lading.
  - (g) For the purposes of this rule, where weight of article lost or damaged cannot be readily ascertained such article shall be deemed to weight not in excess of 7 pounds per cubic foot.
  - ◆(h) For the purpose of this rule, rates and charges herein apply on shipments when released to a value not exceeding 60 cents per pound per article. For rates and charges to apply on shipments where declared value exceeds 60 cents per pound per article, see Item 280.

## GENERAL RULES AND REGULATIONS

RULE 4DETERMINATION OF WEIGHTS

1. Carriers transporting shipments shall determine the weight of each shipment transported prior to the assessment of any charges depending on the shipment weight.
2. Weighing Procedure
  - a. Except as otherwise provided in this item, the weight of each shipment shall be obtained by determining the difference between the tare weight of the vehicle on which the shipment is to be loaded prior to the loading and the gross weight of the same vehicle after the shipment is loaded: or, the gross weight of the vehicle with the shipment loaded and the tare weight of the same vehicle after the shipment is unloaded.
  - b. At the time of both weighings the vehicle shall have installed or loaded all pads, dollies, hand trucks, ramps and other equipment required in the transportation of such shipments. Neither the driver nor any other persons shall be on the vehicle at the time of either weighing.
  - c. The fuel tanks on the vehicle shall be full at the time of each weighing or, in the alternative, no fuel may be added between the two weighings when the tare weighing is the first weighing performed.
  - d. The trailer of a tractor-trailer vehicle combination may be detached from the tractor and the trailer weighed separately at each weighing providing the length of the scale platform is adequate to accommodate and support the entire trailer at one time.
  - e. Shipments weighing 1,000 pounds or less may be weighed on a certified platform or warehouse scale prior to loading for transportation or subsequent to unloading.
  - f. The net weight of shipments transported in containers shall be the difference between the tare weight of the container, including all pads, blocking and bracing used or to be used in the transportation of the shipment and the gross weight of the container with the shipments loaded therein.
  - g. The shipper or any other person responsible for payment of the freight charges shall have the right to observe all weighings of the shipment. The carrier must advise the shipper or any other person entitled to observe the weighings of the time and specific location where each weighing will be performed and must give that person a reasonable opportunity to be present to observe the weighings. Waiver by a shipper of the right to observe any weighing or reweighing is permitted and does not affect any rights of the shipper under these regulations or otherwise.
3. Weight Tickets. The carrier shall obtain a separate weight ticket for each weighing required under this item except when both weighings are performed on the same scale, one weight ticket may be used to record both weighings. Every weight ticket must be signed by the person performing the weighing and must contain the following minimum information:
  - a. The complete name and location of the scale.
  - b. The date of each weighing.
  - c. Identification of the weight entries thereon as being the tare, gross and/or net weights.
  - d. The company or carrier identification of the vehicle.
  - e. The last name of the shipper as it appears on the Bill of Lading.
  - f. The carrier's shipment registration or Bill of Lading number.
  - g. The original weight ticket or tickets relating to the determination of the weight of a shipment must be retained by the carrier as part of the file on the shipment. All freight bills presented to collect any shipment charges dependent on the weight transported must be accompanied by true copies of all weight tickets obtained in the determination of the shipment weight.
4. The provisions of paragraphs (2), (3), and (5) of this item shall not apply to shipments tendered to the carrier in containers or to shipments consisting solely on machinery (including auxiliary and component parts thereof) which are being transported by household goods carriers pursuant to the definition of household goods in paragraph (a) (3) of Item 100 of this tariff; provided, the weight of each shipment is certified by the shipper thereof on this bill of lading covering such shipments.
5. Reweighing of Shipments. Before the actual commencement of the unloading of a shipment weighed at origin and after the shipper is informed of the billing weight and total charges, the shipper may request a reweigh. The charges shall be based on the reweigh weight.

## GENERAL RULES AND REGULATIONS

RULE 5(A) COMPLETE OCCUPANCY OF VEHICLE

Subject to the availability of equipment for the particular service desired, a shipment, the displacement of which completely occupies the loading space of a vehicle, or the peculiar character of which otherwise prevents its transportation with other shipments on the same vehicle, will be accepted at charges computed on the actual weight and subject to a minimum weight based on 7 pounds per cubic foot of total vehicle space. (See Paragraph (F) of this item.)

NOTE: The complete occupancy of vehicle provisions will not apply on residence to residence moves and other shipments transported under Par. 1 of Item 100, Commodity Description of Household Goods.

Bill of Lading and Freight Bill to be marked or stamped:

SHIPMENT COMPLETELY OCCUPIED A \_\_\_\_\_ CU. FT. VEHICLE

(B) EXCLUSIVE USE OF A VEHICLE

1. Subject to the availability of equipment, a shipper may order Exclusive Use of a Vehicle of specific cubic capacity, for transportation of a shipment. Transportation charges shall be based on actual weight subject to minimum charges as follows:

If the capacity of vehicle ordered is 1,400 cu. ft. or less, the minimum charge shall be based on 9,800 pounds.

If the capacity of vehicle ordered is in excess of 1,400 cu. ft., the minimum charge shall be based on 7 pounds per cubic foot of total vehicle space ordered.

2. If at time for loading such shipment, carrier does not have available a vehicle of capacity ordered, carrier may substitute a vehicle or vehicles of an equivalent or greater capacity and transportation charges and minimum therefor shall be the same as would apply had carrier furnished a vehicle of the capacity ordered. (See Paragraph (F) of this item.)

Bill of Lading and Freight Bill to be marked or stamped:

EXCLUSIVE USE OF A \_\_\_\_\_ CU. FT. VEHICLE ORDERED.

3. Outside display by removable signs or banners of van contents of a shipment involving exclusive use of the vehicle will be permitted subject to the carrier's convenience, and providing such removable signs or banners be furnished by and maintained at the expense of the shipper. Any liability resulting because of the carrying of such signs or banners will be that of the shipper, not the carrier. Service will be subject to charges as provided in Section I.

4. Shipper painting of carrier's equipment will be permitted subject to the carrier's convenience and providing the shipper assumes all of the expense of painting and repainting. Repainting of the equipment shall be made according to the carrier's specifications at the termination of the shipment. Such painting shall not interfere with signs or marking required by the Pennsylvania Public Utility Commission or safety regulations.

**GENERAL RULES AND REGULATIONS**

**RULE 5**

**(C) SPACE RESERVATION FOR A PORTION OF VEHICLE**

Subject to the availability of equipment, shipper may reserve a portion of the capacity of a vehicle by ordering a specific quantity of space, and accepting transportation charges based on actual weight of shipment subject to minimum weights as follows:

1. When shipment consists entirely of articles as embraced in Paragraph (a) 3 of Item 100 (except objects of art):

- 150 cu. ft. or less ..... 1,050 Pounds
- 151 to 200 cu. ft. .... 1,400 pounds
- More than 200 cu. Ft. .... 700 pounds per each 100 cu. ft. unit or fraction thereof ordered.

2. When shipment consists entirely of articles as embraced in Paragraph (a) 1 or (a) 2 of Item 100 and on objects of art, as embraced in Paragraph 3 of Item 100:

- 300 cu. ft. or less ..... 2,100 pounds
- More than 300 cu. ft..... 700 pounds per each 100 cu. ft. unit or fraction thereof ordered.

Bill of Lading and Freight Bill to be marked or stamped:

SPACE RESERVATION \_\_\_\_\_ CU. FT. ORDERED

**(D) SIGNATURE REQUIRED FOR SERVICES**

Expedited Service, Exclusive Use of a Vehicle, or Space Reservation for a portion of a Vehicle will be furnished by carrier only when shipper or his agent requests such service in writing or signs the Bill of Lading indicating that such specific special service was ordered.

**(E) DISPLAY OF VAN SPACE**

The number of cubic feet of van space shall be legibly displayed on each side of the vehicle used by the carrier in rendering service under Paragraphs (A) and (B) of this rule.

NOTE: all shipments subject to weighing provisions as provided in Rule 4.

**RULE 6**

**EXPEDITED SERVICE**

1. Expedited Service as used herein means tendering delivery of a shipment of less than 5,000 pounds on or before a specified date.

Subject to the availability of equipment for a particular service desired, shippers may obtain expedited service on a shipment of less than 5,000 pounds and transportation charges shall be computed on the basis of 5,000 pounds and tariff rates applicable to 5,000 pounds. The carrier shall not be required to provide exclusive use of vehicle under this paragraph. For exclusive use of vehicle, refer to Paragraph (B) of Rule 5.

## GENERAL RULES AND REGULATIONS

### RULE 7

#### WEIGHT TICKET OF BILL OF LADING

A certified weight ticket shall be attached to or made part of the Uniform Household Goods Bill of Lading.

### RULE 8

#### DEFINITION OF A SHIPMENT

The term "shipment" means property tendered by one shipper, and accepted by the carrier, at one place of origin and at one time (except as otherwise provided in Rule 9), for one consignee, at one destination (except as otherwise provided in Rule 9), and covered by one bill of lading. The name of only one shipper and one consignee shall appear on one bill of lading, but the bill of lading may also specify the name of a party (or more than one party when Rule 9 is applicable) to notify of the arrival of the shipment at destination(s).

### RULE 9

#### EXTRA PICK-UP OR DELIVERY

Portions of a shipment may be picked up or delivered at one or more places of origin, destination, or en route. Charges will be for total weight of entire shipment for total distance via points of pick-up or delivery or both from first point of pick-up to final point of delivery, plus additional service charges applicable to each portion of the shipment. (See Section 1). The total charges for picked up or delivered portions shall not, in any case, exceed the total charges as would apply if computed to each portion as a separate shipment.

### RULE 10

#### PICK-UP AND DELIVERY AT WAREHOUSE

Except as otherwise provided herein if shipment is delivered to or picked up, at a warehouse, the rates for transportation include only the unloading or loading at door, platform, or other point convenient or accessible to the vehicle.

### RULE 11

#### MILEAGE

▲ (a) Except as otherwise provided herein, where rates are based on mileage, the distance or mileage shall be that shown in Mileage Guide No. 40, TRISTATE HOUSEHOLD GOODS TARIFF CONFERENCE, INC., AGENT, PA. P.U.C. No. 40, supplements thereto, or successive issues thereof. In lieu of Mileage Guide No. 40, carrier may use a software program designed to calculate mileage, such as, Google Maps or MapQuest.

▲ (b) If the shipper requests a longer route than the shortest available regularly traveled highway route, as shown in the above mentioned Mileage Guide or a software program designed to calculate mileage, the mileage over the longer route as shown therein shall apply.

▲ (c) If transportation rates are not shown herein for the actual distance provided in the above mentioned guide or a software program designed to calculate mileage, the rate shown for the next greater distance shall apply.

### RULE 12

#### INTERMEDIATE APPLICATION

▲ (a) If any point of origin or any point of destination is not shown in Mileage Guide No. 40, Tristate Household Goods Tariff Conference, Inc., Agent, PA. P.U.C. No. 40, supplements thereto or successive issues thereof or a software program designed to calculate mileage, such as, Google Maps or MapQuest, the mileage from or to the next more distant point shown shall apply.

▲ (b) If transportation rates are not shown herein for the actual distance provided in the above mentioned Mileage Guide or a software program designed to calculate mileage, the rates shown for the greater distance shall apply.

RULE 13MARKING AND PACKING

- (1) Articles of fragile or breakable nature must be properly packed.
- (2) Packages containing fragile articles or articles consisting wholly or in part of glass, when packed by the shipper or his agent, must be marked by plain and distinct letters designating the fragile character of contents.
- (3) When articles of furniture, consisting wholly or in part of glass are covered or wrapped by the shipper or his agent, such articles shall be wrapped in a manner to clearly expose glass surfaces or glass portions.

RULE 14COMPLETE ARTICLE

Each shipping piece or package and contents thereof shall constitute one article except the total component parts of any article taken apart or knocked down for handling or loading in vehicle shall constitute one article for the purpose of determining carrier's liability as provided in Rule 3.

NOTE: When an entire shipment is transported in containers, lift vans or shipping boxes, each shipping package, piece of loose item not enclosed within a package in such containers, lift vans or shipping boxes will constitute the article.

RULE 15REISSUED ITEMS OR PAGES

Reference made herein to items or pages in this tariff include reference to reissue of such items or pages.

RULE 16ARTICLES OF HIGH OR EXTRAORDINARY VALUE NOT ACCEPTED

Unless otherwise provided, the following property will not be accepted for shipment:

Bank Bills, coin or currency, deeds, notes, drafts, or valuable papers of any kind, jewelry, postage stamps, stamp collections, revenue stamps, letters, precious stones, or articles of peculiarly inherent or extraordinary value; precious metals or articles manufactured therefrom. Should such articles come into the possession of the carrier without his knowledge, responsibility for safe delivery will not be assumed.

(a) Explosives or dangerous goods will not be accepted for shipment. Any person or persons, whether principal or agent, shipping such goods, shall be liable for and indemnify the carrier against all loss or damage caused by such goods and carrier shall not be liable for safe delivery of the shipment.

(b) The rates in this tariff do not obligate the carriers to receive property liable to impregnate or otherwise damage equipment or other property. Such property may be accepted and receipted for "Subject to delay for suitable equipment" or for lack of suitable equipment, may be refused.

(c) Carrier will not accept for shipment articles which cannot be taken from the premises without damage to the article or the premises.

**RULE 18****DISASSEMBLING AND REASSEMBLING**

The line-haul transportation rates DO NOT include removing any outdoor article embedded in the ground or secured to a building, not the assembling or disassembling of any outdoor articles such as steel utility cabinets, swing set, slides, sky rides, jungle gyms, or other outdoor articles of similar nature, nor the assembling or disassembling of unusual articles found inside of buildings such as German schranks, water beds, steel shelving, pool tables, elongated work tables, counters, etc. Upon request of shipper, owner or consignee, the carrier will disassemble or reassemble such articles, subject to charges provided in Item 120. The shipper, in such case, will be required to furnish, at the time of reassembling, any new hardware, nuts, bolts, etc., necessary to perform this service.

**RULE 19****INSPECTION OF PACKAGE**

When carrier or his agent believes it necessary that the contents of packages be inspected, he shall make or cause such inspection to be made, or require other sufficient evidence to determine the actual character of the property.

**RULE 20****SERVICING SPECIAL ARTICLES**

The transportation rates in this tariff do not include the servicing or reservicing of articles or appliances including but not limited to refrigerators, deep freeze cabinets, radios, record players, washing machines, television sets, air conditioners, grandfather clocks and boats, which if not properly serviced, may be damaged in or incident to transit; nor is liability assumed for such damage unless such articles or appliances are serviced as provided in (a) and (b) below.

The carrier reserves the right to inspect these articles or appliances to determine whether they are in good working order before accepting them for shipment. Carrier assumes no liability whatsoever for the charges of third persons for the resynchronization of grandfather clocks including the pendulum or weights therefor which were disassembled at origin by carrier or the returning, refocusing or other adjustments of television sets unless such services were made necessary due to carrier's negligence.

(a) Upon request of shipper, owner or consignee of the goods, carrier will, subject to (b) below, service and reservice or prepare for shipment such articles and appliances at origin and destination for the additional charge provided in Section 1 (Item 120 applies for boats. Item 220 applies for all other appliances and articles). Such servicing and reservicing and preparation does not include removal or installation of articles secured to the premises; or plumbing, electrical or carpentry services necessary to disconnect, remove, connect and install such articles and appliances.

(b) If carrier does not possess the qualified personnel to properly service, reservice or prepare for shipment such articles or appliances, carrier will upon request of shipper, owner or consignee and as agent for them engage third persons to perform the servicing, reservicing or preparation for shipment.

(c) All charges of the third persons must be paid by the shipper, and are in addition to all other charges in this tariff. Such charges will be advanced by the carrier, and billed as an advanced charge as provided in Rule 44.

RULE 21

SHIPMENTS ACCEPTED SUBJECT TO LAWS

Shipments will be accepted subject to requirements of ordinances or limitation of law regulating the transportation of the property, or the use of vehicle and facilities.

RULE 22

ADDITIONAL SERVICES

Except as otherwise provided herein, rates or charges named covering "Terminal Services" and "Additional Services" rendered by the carrier, are in addition to the transportation rates named in this tariff.

RULE 23

CARRIER'S OBLIGATION FOR SERVICE

- (a) Carrier's obligation to accept property for shipment is subject to capacity, type of vehicle, facilities, equipment and personnel available.
- (b) Carrier is not obligated to transport property by any particular vehicle, train or vessel, or otherwise than with reasonable dispatch.

RULE 24

WAITING OR DELAY

Rates and charges for waiting time or delay, as shown herein, will apply when vehicle is held for convenience of shipper or consignee, through no fault of the carrier.

RULE 25

IMPRACTICAL PICK-UP OR DELIVERY AND AUXILIARY SERVICES

- (a) It is the responsibility of the shipper to make shipment accessible to carrier or accept delivery from carrier at a point at which the road haul vehicle may be safely operated.
- (b) When it is physically impossible for carrier to perform pick-up of shipment at origin address or to complete delivery of shipment at destination address with normally assigned road haul equipment, due to the structure of the building, its inaccessibility by highway, inadequate or unsafe public or private road, overhead obstructions, narrow gates, sharp turns, trees, shrubbery, the deterioration of roadway due to rain, flood, snow, nature of an article or articles included in the shipment, the carrier shall hold itself available at point of pick-up or tender delivery at destination at the nearest point of approach to the desired location where the road haul equipment can be made safely accessible.
- (c) Upon request of the shipper, consignee or owner of the goods the carrier will use or engage smaller equipment than its normal road haul equipment or provide extra labor for the purpose, if possible of accomplishment, of transferring the shipment between the origin or destination address and the nearest point of approach by the carrier's road haul equipment. Charges for the auxiliary service to cover labor and additional vehicle (if used) will be as provided in Section 1 and shall be in addition to all other transportation or accessorial charges.
- (d) If the shipper does not accept the shipment at nearest point of safe approach by carrier's road haul equipment to the destination address, the carrier may place the shipment or any part thereof not reasonably possible for delivery, in storage at the nearest available warehouse of the carrier, or, at the option of the carrier, in a public warehouse, subject to a lien for all lawful charges. The liability on the part of the carrier will cease when the shipment is unloaded into the warehouse and the shipment shall be considered as having been delivered.
- (e) Transportation charges to cover the movement of shipment or part thereof from point at which it was originally tendered, to warehouse location shall be computed on basis of weight of shipment or that part of shipment stored in warehouse, subject to applicable rate as provided in tariff from point at which it was originally tendered to warehouse location, which shall be in addition to charges from initial point of origin to point at which shipment was originally tendered. All accrued charges on the shipment or any part thereof shall be due and payable upon delivery of same to the warehouse. Any subsequent movement from warehouse shall constitute a new shipment.

RULE 26  
PAYMENT

(a) The carrier will not deliver or relinquish possession of any property transported by it until all tariff rates and advanced charges thereon have been paid in cash, money order, or certified check, except where other arrangements have been made in accordance with rules and regulations of the Pennsylvania Public Utility Commission.

(b) Nothing herein shall limit the right of the carrier to require at the time of or before shipment, the prepayment in part or in full or guarantee of the charges. If, upon inspection, it is ascertained that the articles shipped are not those described in the Bill of Lading, the tariff charges must be paid upon the articles actually being shipped.

RULE 27  
SHIPMENTS ON TOUR

One or more articles making up a shipment for use or display at two or more places, which shipment requires the exclusive use of a vehicle to transport such property and which requires reloading and moving to another point for use, display or termination of the tour, shall constitute a shipment on tour.

(a) Transportation and Valuation Charges:

Transportation charges (subject to the minimum weight provisions shown in Paragraph (b) below) for a shipment on tour will be the rates in Section 2 of tariff, and shall be the combination of charges between each stopping point at the rates as would ordinarily apply on a completed shipment between such points. The applicable transportation rates in Section 2 of tariff shall be those in effect on the date each segment commenced for movement to another point.

(b) Minimum Weights:

1. Transportation charges on shipments transported 21 miles or more between stops, constituting of articles (other than automobiles exclusively), will be subject to the minimum weight provisions of Rule 5(B), Exclusive Use of a Vehicle.
2. Transportation charges on shipments transported 21 miles or more between stops, consisting exclusively on an AUTOMOBILE(S), will be based on either the actual weight of the entire shipment, or the following constructive weight, whichever is greater:

One automobile on a single van	8,400 lbs.
Two automobiles on a single van	14,000 lbs.
Three automobiles on a single van	18,900 lbs.
Four or more automobiles on a single van	21,000 lbs., plus 2,100 lbs. for each automobile over four automobiles

3. Transportation charges on shipments transported 20 miles or less will be at actual weight subject to a 5,000 pound minimum.

RULE 27SHIPMENTS ON TOUR (Continued)

One or more articles making up a shipment for use or display at two or more places, which shipment requires the exclusive use of a vehicle to transport such property and which requires reloading and moving to another point for use, display or termination of the tour, shall constitute a shipment on tour.

(c) Dock Service Allowance:

When a shipment on tour, rated at 18,900 pounds or more, (14,000 pounds or more for automobiles), is loaded from, or unloaded onto a dock, platform or similar facility, the transportation charge will be reduced as follows:

1. \$0.31 per cwt. where dock loading service is utilized and the distance to the next stopping point is 300 miles or less, and \$0.66 per cwt. for distance in excess of 300 miles. (Based on actual weight subject to 500 pound minimum).
2. \$0.31 per cwt. where dock unloading service is utilized and the distance from the last stopping point was 300 miles or less, and \$0.61 per cwt. For distances in excess of 300 miles. (Based on actual weight subject to 500 pound minimum).

"Dock Loading Service" shall mean the tender by the shipper and the acceptance by the carrier of a shipment (on tour) at a dock, platform or similar facility readily accessible and suitable for loading of carrier's vehicle, with all handling by the shipper or third persons engaged by the shipper of each separate article in the shipment from its resting place within a building or elsewhere onto the dock, platform or similar facility.

"Dock Unloading Service" shall mean the tender by the carrier and the acceptance by the shipper of a shipment (on tour) on a dock, platform or similar facility readily accessible and suitable for unloading of carrier's vehicle with all handling by the shipper or third persons engaged by the shipper of each separate article in the shipment from such dock, platform or similar facility to its resting place within a building or elsewhere.

(d) Standby of Vehicle and Drivers:

1. When so ordered by the shipper in writing, carrier's vehicle and driver will standby while the shipment is being used or displayed, subject to a standby charge of \$99.35 for vehicle and driver and \$48.35 for driver-helper for each 12 hour period or fraction thereof, including Sundays and holidays.
2. The calculated time for the standby charge will commence after the vehicle is unloaded and terminate when reloading of the vehicle is commenced.
3. During such standby, period, the standby charge shall include the service of the driver and driver's helper for Labor and supervision incidental to the transportation of shipment, subject to the hours of service regulations of the Pennsylvania Public Utility Commission.

One or more articles making up a shipment for use or display at two or more places, which shipment requires the exclusive use of a vehicle to transport such property and which requires reloading and moving to another point for use, display or termination of the tour, shall constitute a shipment on tour.

(e) Travel Time- Extra Delivery

1. Subject to the limitations and restrictions provided for in Paragraph 2 below, carrier undertakes to transport shipment on tour a maximum distance of 300 miles for each 24 hour period computed from the time loading of the shipment has been completed to the tender of delivery at the next stop. When shipper requests carrier to transport such shipment distances in excess of 300 miles for each 24 hour period, carrier will furnish an extra driver at the following additional charges:

\$9.70 per hour for the extra driver's service based on the time vehicle departs from the point of loading until the time vehicle arrives at point of unloading, plus the following charge for transportation for the return of extra driver to the point of loading:

500 miles or less	51¢ per mile
501 to 1,000 miles	43¢ per mile
1,001 to 1,500 miles	36¢ per mile
1,501 miles and over	31¢ per mile

2. Shipper shall not request and carrier shall not be required to make delivery of a Shipment on Tour at a specific time or date if, considering the distance involved, such transportation and delivery would result in a violation of the rules and regulations of the Pennsylvania Public Utility Commission. Any such request or requirement shall not be binding on the carrier.

(f) Delay Charges:

If the shipper does not accept shipment when tendered for delivery by carrier, a charge of \$16.50 per hour for vehicle and driver and \$9.70 per hour per driver-helper will apply for each hour or fraction thereof delay occurring between the hours 8:00AM and 5:00PM excluding Sundays and holidays for each hour in excess of 24 hours for each 300 miles between point of loading and point of unloading.

(g) Carrier Supervision Other Than Regular Van Crew:

When carrier-supplied supervision (other than the regular van crew) is requested by the shipper, a charge of \$37.95 per hour per supervisor will be assessed.

One or more articles making up a shipment for use or display at two or more places, which shipment requires the exclusive use of a vehicle to transport such property and which requires reloading and moving to another point for use, display or termination of the tour, shall constitute a shipment on tour.

(h) Third Party Labor:

Stage hands, exhibition workers, or like third party labor, which may be required by civil or union jurisdictional regulations, shall be by and at the expense of the shipper.

(i) Removable Signs and Banners:

The use of the outside of van, at the request of the shipper, of removable signs or banners to indicate the identity of the shipper, the contents of the van and/or the nature of the shipment on tour will be permitted providing such removal signs or banners be furnished by and maintained at the expense of the shipper. Any liability resulting because of the carrying of such signs or banners will be that of the shipper, not the carrier. Service will be subject to charges provided in Section 1.

(k) Trailers provided by shipper:

1. The transportation charges (subject to provisions of Paragraph (a) and (b) of this item) will be reduced to \$0.09 per mile, bases on miles at which transportation rate is based.
2. Shipper shall be solely responsible for any liability, damage, or injury which may occur either to person or to property while the trailer is set up and/or on display; except with respect to liability solely due to the fault or negligence of the carrier. Shipper shall also be solely responsible for any liability, damage or injury which may be caused at any time by mechanical defect not apparent by normal visual inspection.
3. Shipper shall be solely responsible for the cost of required trailer licenses, permits, or decals, as determined by carrier, and for the maintenance and repair costs of the trailer, subject to the provisions of Rule 44, Advanced Charges.
4. Carrier shall not be liable for loss or damage to the trailer (walls, roof, wheels, tires, undercarriage, floors, doors, or any other portion thereof not constituting an integral part of the actual display or exhibit).
5. Carrier liability for cargo loss or damage shall apply to the contents of the trailer limited to the net weight of said contents and subject to all other tariff rules and provisions.
6. When tour does not terminate at the same point tour commenced, an additional charge of \$0.51 per mile will be assessed from point of termination to origin point of tour.
7. Carrier may reject a trailer tendered by the shipper for reasons such as, but not limited to: trailer is unsafe or does not comply with federal or state safety requirements; trailer is not compatible with carrier power equipment; trailer size, weight or length.

NOTE: Any services provided by carrier for which charges are not provided for in this rule, will be at the applicable charges shown in Section 1, Additional Services.

RULE 28

CLAIMS

- (a) Any claim for loss, damage, or overcharge shall be in writing and shall be accompanied by original paid bill for transportation and original bill of lading, if not previously surrendered to carrier. Carrier may require certified or sworn statement of claim.
- (b) Carrier should be notified immediately of all claims for concealed damage and shall be given reasonable opportunity to inspect concealed damage in original package.
- (c) The carrier's liability shall not exceed the cost of repairing or replacing the property lost or damaged with materials of likekind and quality not exceeding the actual cash value of the property at the time and place of loss, with due allowance for depreciation or deterioration howsoever caused, but in no event to exceed the released value declared by the shipper in accordance with Pennsylvania Public Utility Commission Released Valuation Rate Docket No. 46 of August 8, 1955. (Exception-Rule 46).
- (d) The carrier's liability for goods shall cease when the property has been delivered to and receipted for by the owner, or by the consignee or shipper or the authorized agent or either, except as to damage noted at time of delivery. When the carrier is directed to unload or deliver property (or render any services) at a place or places at which the consignee or its agent is not present, the property shall be at the risk of the owner after unloading or delivery.
- (e) Where the carrier is directed to load property from (or render any services at) a place or places at which the consignor or its agent is not present, the property shall be at the risk of the owner before loading.
- (f) The carrier's liability with regard to sets or matched pieces shall be limited to repair or replacement of the lost or damaged piece or pieces only and shall not extend to repair, replacement or recovering of the entire set, but in no event to exceed the released value declared by the shipper in accordance with Pennsylvania Public Utility Commission Released Valuation Rate Docket No. 46 of August 8, 1955. (Exception Rule 46).
- (g) For the purpose of assessing carrier's liability, where such liability is measured by the weight of an article and in absence of specific evidence to the contrary, the following containers and/or cartons shall be deemed to have the following weights.

DISPOSITION OF FRACTIONS

Unless otherwise provided, to dispose of fractions in computing a charge omit fractions of less than one-half of one cent, and increase to the next whole figure fractions of one-half of one cent or greater.

RULE 31  
HOURLY RATES

Charges based on time shall be computed by multiplying the hourly rate by the time involved. Unless otherwise provided, fractions of an hour will be disposed of as follows: Where the time involved is less than 15 minutes, the charge shall be for one quarter of an hour. When in excess of 15 minutes but not more than 30 minutes, charge for one half hour. When in excess of 30 minutes but not more than 45 minutes, charge for three quarters of an hour. When in excess of 45 minutes, charge for one hour.

RULE 32  
LIMITATIONS OF CERTIFICATE OR PERMIT

The adoption or incorporation of any or all of the rules, regulations or rates named in this tariff by any carrier, shall not be construed to grant or extend the rights or privileges of such carrier beyond those granted in the certificate issued to such carrier by the Pennsylvania Public Utility Commission.

RULE 33  
MINIMUM WEIGHT CHARGE

Except as may be otherwise specifically provided for in this tariff, or as amended, the minimum weight for shipments described in Item 100, paragraphs (1) and (2) (1st Proviso) will be based upon 500 pounds. NOTE: All shipments subject to weighing provisions as provided in Rule 4.

RULE 34  
ALTERNATE CHARGES

Where charges are stated in amounts per hundred pounds, the total charge on any shipment shall not exceed the charge as would apply on the same shipment under the next greater unit of weight at rate applicable to the greater unit of weight. To illustrate: A shipment weighing 1,700 pounds, distance 100 miles, rate \$6.75-\$114.75. Use lowest weight in next higher bracket - 2,000 pounds, distance 100 miles, rate \$5.50 - \$110.00.

COMPUTING CHARGES

Unless otherwise provided herein where rates are stated in amounts per hundred pounds, charges shall be computed by multiplying the total weight involved by the rate shown for a hundred pounds.

RULE 36MOVEMENT OF EMPTY VEHICLES

(a) Subject to availability of equipment, shipper desiring continuous movement of a shipment, or more than one shipment, may request the empty movement of equipment from destination to point of origin of the shipment or next shipment, for further loading, at charges shown in Section 1, Additional Services, herein. The empty movement of equipment shall be ordered in writing at the time shipments are accepted for transportation.

(b) Empty mileage operated from destination to point of origin of shipment, or next shipment, shall be that shown in Mileage Guide No. 40, Tristate Household Goods Tariff Conference, Inc., Agent, PA. P.U.C. No. 40, supplements thereto or successive issues thereof.

RULE 37MILEAGE DETERMINATION OF WAREHOUSE SHIPMENTS

When shipments or portions thereof moving to or from a warehouse involve origin and destination, both shown on the same vicinity map of the effective mileage guide and warehouse is located within a municipality for which a key point is shown on such vicinity map, mileage for the purpose of developing transportation charges shall be computed to such key point irrespective of the location of warehouse within the key point municipality.

RULE 38SHIPMENTS OF DISPLAYS AND EXHIBITS

On shipments, other than shipments on tour, transported in excess of 250 miles, consisting entirely of displays and exhibits or parts thereof, mockups, models and prototypes (excluding automobiles or mockups, models or prototypes of automobiles), embraced in Paragraph 3 of Item 100, an allowance of \$1.00 per cwt. based on weight at which transportation rate is based, will apply to each such shipment rated at 1,000 pounds or more for which carrier renders both a tailgate pickup service and a tailgate delivery service.

NOTE: The term "tailgate pickup service" shall mean tender by the shipper and acceptance by the carrier of a shipment at the loading door of the carrier's vehicle, with all handling of each separate article in the shipment from its original resting place within a building or elsewhere to such vehicle loading door being performed by or at the expense of the shipper, and the term "tailgate delivery service" shall mean delivery by the carrier and acceptance by the consignee of a shipment at the vehicle unloading door with all handling of each separate article in the shipment to its final resting place within a building or elsewhere being performed by or at the expense of the shipper.

RULE 39PERISHABLE FOOD

- (a) Carrier will not accept for shipment perishable articles including frozen foods, articles requiring refrigeration or perishable plants except as provided in Paragraphs (b), (c) or (d).
- (b) Frozen food will be accepted for transportation provided.
1. The food is contained in a freezer which at time of loading is at normal deep freeze temperature.
  2. The shipment is to be transported not more than 150 miles and/or delivery accomplished within twenty-four (24) hours from time of loading.
  3. No storage of shipment is required.
  4. No preliminary or en route servicing by use of dry ice, electricity, or other preservative methods is required of the carrier.
- (c) Perishable plants will be accepted for transportation provided.
1. The shipment is transported not more than 150 miles and/or delivery accomplished within twenty-four (24) hours from the time of loading.
  2. No storage is required
  3. No preliminary or en route servicing or watering or other preservative method is required of the carrier.
- (d) The carrier will not be responsible for any perishable article included in a shipment without the knowledge of the carrier.

RULE 40COLLECT ON DELIVERY (C.O.D.) SHIPMENTS

- (a) For the purpose of this item, C.O.D. charges apply only to monies due the consignor and do not apply to charges collected at time of delivery for transportation or other additional services.
- (b) In the handling of C.O.D. shipments, carrier shall collect C.O.D. amounts payable in cash, certified check, traveler's check, or bank check (one drawn by a bank on itself and signed by an officer of the bank) at time of delivery and shall remit each C.O.D. collection directly to the consignor, or other person designated by the consignor as payee, promptly and within ten (10) days after delivery of the C.O.D. shipment to the consignee.
- (c) When a C.O.D. shipment moves in interline service, the delivering carrier shall, at the time of remittance of the C.O.D. collection to the consignor or payee, notify the originating carrier of such remittance.
- (d) The charge for C.O.D. collection service shall be \$4.45 for each \$1,000 or fraction thereof collected.

RULE 41IMPRACTICABLE OPERATION

The carrier shall not be obligated to perform pick-up or delivery or render any service at a place or places from or to which it is impracticable to operate vehicles because of:

- (1) The condition of roads, streets, driveways, alleys, or approaches thereto.
- (2) Inadequate loading or unloading facilities.
- (3) Any riot, strike, picketing or other labor disturbances.

RULE 42DIVERSION OF SHIPMENTS

- (a) Upon instructions made or confirmed in writing by the consignee or owner, a shipment will be diverted subject to the following provisions and additional charges shown in paragraph (e) below.
- (b) The term diversion as used herein means:
- (1) A change in the destination (after loading of vehicle) outside of a 30 mile radius from the original destination point.
  - (2) A change in the route at the request of the consignor, consignee or owner.
- (c) When an order for diversion under this rule is received by a carrier, diligent effort will be made to locate the shipment and effect the change desired, but the carrier will not be responsible for failure to effect the change ordered, unless such failure is due to the error or negligence of the carrier or its employees.
- (d) Transportation charges on a shipment diverted to a new destination city, while vehicle is enroute to or upon arriving at original destination city, will be assessed at:
- (1) The thru rate from point of origin to point of final destination via the actual point of diversion, or
  - (2) The thru rate from point of origin to point of final destination via the original destination point, whichever is less (NOTE 1).
- (e) On shipments diverted to a new destination city under provisions of Paragraph (d) above, an additional charge of \$4.15 per cwt. will apply, based on weight at which transportation rate is based, EXCEPT if shipment is moving under provisions of Rule 5, Paragraph (A) Complete Occupancy or Paragraph (B) Exclusive Use of a Vehicle; or if shipment weighs or is rated at 12,000 lbs. or more; the above charge will not apply, and in lieu thereof, a charge of \$34.55 per diversion will apply. If the new destination city is within 30 miles of the original destination city, no diversion charge will apply.

NOTE 1: On shipments diverted to a warehouse for storage-in-transit at a city other than original destination city, the warehouse will be considered the destination point, and transportation charges to the warehouse will be assessed under the provisions of Paragraph (d) above, plus the additional charge provided in Paragraph (e) above. Charges for storage, warehouse handling and further transportation will be made according to rates, rules and regulations named in this tariff as amended.

NOTE 2: If instructions are received to divert a shipment that is in storage-in-transit, the provisions and charges of this rule will apply, and transportation charges will be computed under the provisions of Rule 45.

RULE 43RIGGING, HOISTING OR LOWERING

When it is necessary to use rigging, hoisting or lowering services in order to accomplish pick-up or delivery of a shipment, carrier will perform such services at the rates provided in Section 1, Item 120, Labor Charges, subject to carrier's ability to furnish equipment and experienced personnel.

If requested by shipper, consignee or owner, carrier will as agent for shipper, consignee or owner, undertake to secure such services from a third party, if available. All charges of third persons must be paid by the shipper and are in addition to all other charges in this tariff. Such charges will be advanced by the carrier, and billed as an advanced charge as provided in Rule 44 herein.

If carrier is unable to furnish or secure the equipment or experienced personnel, the shipper, owner or consignee of the goods must arrange for such service.

RULE 44ADVANCED CHARGES

Charges advanced by carrier for services of others engaged at the request of the shipper will be supported by carrier with a copy of invoice setting forth services rendered, charges and basis thereof, together with reference to applicable schedule or tariff if changes are assessed in accordance therewith. The charges so advanced are in addition to and shall be collected with all other lawful rates and charges.

When carrier engages the services of third persons at the request of and as agent for the shipper, carrier will not assume responsibility for their activities or conduct, amount of their charges, nor for the quality or quantity of service furnished.

RULE 45STORAGE-IN-TRANSIT (S.I.T.)

(a) Storage-In-Transit of property covered by this tariff is the holding of the shipment or portion thereof at or in the facilities or warehouse used by the carrier or its agent, for storage, pending further transportation, and will be effected only at specific request of the shipper or under the conditions specified in Paragraph (n) of this item. For the purpose of this item a carrier may designate any facility or warehouse to serve at its agent.

(b) A shipment or portion thereof may be placed in storage-in-transit one or more times for an aggregate period not to exceed 90 days. When not removed from storage-in-transit at midnight on the 90th day, liability as carrier shall terminate after such time, the intrastate character of the shipment or portion thereof shall cease, the warehouse shall be considered the destination of the property, the warehouseman shall be agent for the shipper, and the property shall then be subject to the rules, regulations and charges of the warehouseman. Until all lawful charges are paid, property will remain in carrier's or agent's warehouse subject to a lien for all such charges.

(c) When storage-in-transit is at origin, charges (subject to Rule 26) may be billed after storage-in-transit is effected as follows:

1. Transportation charges between origin and warehouse where storage-in-transit is effected.
2. Storage charges due at time of billing.
3. Charges for additional services, advances and other lawful changes.

(d) When storage-in-transit is at other than origin, charges (subject to Rule 26) must be billed at the time storage-in-transit is effected, as follows:

1. Transportation charges between origin and warehouse where storage-in-transit is effected.
2. Charges for additional services, advances and other lawful changes.

At the time of billing under this paragraph, storage charges due the carrier may be billed. Storage charges for subsequent days of storage that property remains in storage-in-transit, may be billed as they become due.

(e) Delivery of shipments to residence from storage-in-transit at origin, en route or at destination will be made on the date requested, if possible. If prior commitments of carrier prevent delivery on that date, every effort will be made to deliver as soon as possible, subject to the following:

1. If shipment is not removed from the storage warehouse by the 5th working day (excluding Saturday, Sunday and holidays) after the agreed delivery date(s), storage charges will cease to accrue after such date.
2. If shipment is removed from the storage warehouse prior to the 5th working day after the agreed delivery date(s), storage charges will cease to accrue the day after shipment is removed.

All other provisions under the tariff will continue in effect until further transportation is made available by the carrier. Until all lawful charges are paid, property will remain in carrier's or agent's warehouse subject to a lien for all such charges.

RULE 45STORAGE-IN-TRANSIT (S.I.T.) (Continued)

(f) The transportation charges to apply when the shipment or portion thereof is stored in transit will be (1) the applicable transportation rate between initial point of pick-up and warehouse, and (2) the applicable transportation rate from warehouse location, which, for rate application purposes, will be considered a new point of origin, to destination point, viz.:

When point of pick-up or delivery and warehouse are both located within the same municipality or within a distance of 30 miles or less, the pick-up or delivery transportation rate will be as shown in Section 3, based upon location of warehouse, or

When point of pick-up or delivery and warehouse are not within the same municipality or not within a distance of 30 miles or less, apply transportation rate in Section 2, between point of pick-up or delivery and municipality in which warehouse is located.

(g) The transportation charges to apply on a shipment when only a portion of the shipment is stored in transit en route to destination, will be the applicable transportation rate based on total weight of entire shipment, for total distance via all points of pick-up and/or delivery (from first point of pick-up to final point of delivery), plus additional service charges applicable to each portion of the shipment. The total charges for picked-up and/or delivered portions shall not, in any case, exceed the total charges as would apply if computed to each portion as a separate shipment. (The provisions of Paragraph (f) of this item will apply from the point of origin to warehouse location for determination of separate charges on the portion of shipment stored in transit, when computing the lower overall total charges.)

(h) The transportation charges to apply on a portion of a storage-in-transit shipment delivered from warehouse location to destination, will be the applicable transportation rate based on the weight of such portion, subject to the provisions of Paragraph (f) of this item.

(i) On property consigned to storage-in-transit wherein an overflow of property requires a split shipment delivered to the warehouse on different dates, the charges for such property shall be as follows:

1. Transportation charges from initial point of pick-up to warehouse location will be based on the combined weight of the property stored in transit, and computation of transportation charges will be as provided in Paragraph (f) of this item.
2. Storage charges in effect on date of initial pick-up will be assessed separately on each portion of shipment stored in transit, except the 1,000 pounds minimum weight rated separately on each portion added, subject to provisions of Item 200.
3. Warehouse handling charge will apply only once, based on the combined weight of the property stored in transit.
4. All subsequent charges will be based on the combined weight of the property stored in transit.

(j) Shipper or owner, upon proper notice in writing to the carrier before departure of the property, may change destination originally shown on the bill of lading. When the destination is changed, such change must be recorded on the bill of lading.

(k) When storage-in-transit property has been placed in a carrier's or agent's warehouse, both the carrier and the warehouse must have in their possession records showing the following:

1. An itemized list of the property with the bill of lading number noted thereon.
2. Point of origin and destination.
3. Condition of each article when received at and forwarded from the warehouse.
4. The dates when all charges, advances or payments were made or received.
5. Dates property was delivered into and forwarded from the warehouse.

RULE 45STORAGE-IN-TRANSIT (S.I.T.) (Concluded)

(l) During storage-in-transit shipper may withdraw a portion of the property, provided that all accrued charges on the property are paid prior to such withdrawal, except as provided in Rule 26. When the selection of items requires unstacking and/or restacking of the shipment or a portion of the shipment, charges for such handling shall be assessed in accordance with Item 120. Charges for transportation furnished, if any, for portion selected for delivery shipment. With reference to the portion of the shipment which remains in the warehouse, shipper may elect in writing to terminate the storage-in-transit service and place the remaining property in storage with the warehouseman in possession, in which event the warehouse will be considered the destination of the property. If the shipper elects to have the remaining portion remain in storage-in-transit, the following shall be applicable:

1. Storage charges shall continue to apply on the weight of remainder of the property.
2. Charges for transportation furnished, if any, for the delivery of the remainder of the property shall be assessed on the same basis as would apply to that portion as an individual shipment.

(m) During the storage-in-transit period shipper may add property to that already in storage-in-transit. Charges for such property added shall be as follows:

1. Transportation charges to apply on the addition, between initial point of pick-up and warehouse, will be as provided in Paragraph (f) of this item.
2. Warehouse handling charge as provided in Item 200 will apply on the addition, subject to 1,000 pound minimum.
3. First day storage charges will apply on the weight of the added property subject to 1,000 pound minimum.
4. All subsequent charges including storage-in-transit will be based on the total weight of the combined property.

(n) If delivery cannot be made at the address specified on the bill of lading because of impractical operation as defined in Rule 41 hereof, or for any other reason other than the fault of the carrier, and neither shipper, consignor, nor owner designates another address at which delivery can be made, carrier will place the property under the storage-in-transit provisions of this item.

NOTE 1: Except as specifically provided for in Paragraph (i) herein, when property is placed in storage-in-transit in segments on different dates:

- (1) the transportation rates and additional service charges in effect on the date of placement of the first segment will apply to that segment only, and
- (2) the transportation rates and additional service charges in effect on the date(s) that subsequent segment is placed in storage-in-transit will apply to these subsequent segments.

NOTE 2: When property is removed from storage-in-transit and extra pick-ups are ordered:

- (1) the transportation rates and additional service charges in effect on the date that the extra pick-up is performed will apply to the entire weight of the extra pick-up, and
- (2) the transportation rates and additional service charges in effect on the date(s) that each subsequent segment is placed in storage-in-transit will apply to these subsequent segments.

NOTE 3: Except as specifically provided for in Paragraph (i) herein, each portion of the shipment will be rated at the applicable rate in effect on the date of pick-up of each portion, based on the total weight of the entire shipment.

NOTE 4: See RULE 49 for provisions governing NOTIFICATION BY CARRIER WHEN STATUS OF A STORAGE-IN-TRANSIT SHIPMENT CHANGES.

**RULE 47**

**FULL VALUE PROTECTION**

1. When Full Value Protection is ordered in writing by the customer, carrier will guarantee either replacement of articles lost or damaged while in carrier's custody, reimbursement for full replacement cost (as determined by current market value) or repairs, or the cost of repairs to damaged item(s) to the extent necessary to restore the item to the same condition as when received by carrier from the shipper. Actual replacement articles, if any, shall consist of articles of like kind and quality without deduction for depreciation.
2. Carrier's maximum liability shall not exceed the released or declared value on the shipment or the full cost of repair to the damaged property, whichever is less. Carrier shall have the option of repair or replacement of damaged articles.
3. All items which are replaced or for which the full current market value has been paid become the property of the carrier.
4. Full Value Protection will be provided by carrier only if shipment is declared at a minimum lump sum of \$21,000.00 or \$6.00 for each pound of weight in the shipment, whichever is greater.

EXCEPTION 1: Provisions of Rule 28 (Claims) when in conflict with this item, WILL NOT APPLY when Full Value Protection is provided by carrier.

**RULE 48**

**TRAVEL TIME AND EXTRA DRIVER**

Line haul transportation in this tariff do not include the services of more than one driver. Upon request of shipper, carrier will furnish an extra driver if operational consideration permit. Charges for the extra driver, if furnished, will be as follows, and shall be in addition to all other applicable tariff charges:

\$9.70 per hour for the extra driver's service based on the time vehicle departs from the point of loading until the time vehicle arrives at point of unloading, plus the following charge for transportation for the return of extra driver to point of loading.

500 miles or less	51¢ per mile
501 to 1,000 miles	43¢ per mile
1,001 to 1,500 miles	36¢ per mile
1,501 miles and over	21¢ per mile

NOTE 1: This item WILL NOT APPLY when carrier, for its own convenience, utilizes an extra driver.

**RULE 49**

**NOTIFICATION BY CARRIER WHEN STATUS OF A STORAGE-IN-TRANSIT SHIPMENT CHANGES**

Carrier rendering storage-in-transit (S.I.T.) shall, notify the shipper in writing, no less than 10 days prior to the expiration of either the specified period of time during which goods are to be held in such storage or the maximum period of time provided in Rule 45 for storage-in-transit, (1) of the date of conversion to permanent storage, (2) of the existence of a 9-month period subsequent to the date of conversion to permanent storage during which shipper may file claims against the carrier for loss and/or damage which occurred to the goods in transit or during the S.I.T. period, and (3) of the fact that on the date of conversion, the liability of the carrier shall terminate and the property shall be subject to the rules, regulations, and charges of the warehouseman. Said notification shall be by certified mail, return receipt requested. Carrier holding goods for storage-in-transit for a period of time less than 10 days shall, no less than 1 day prior to the expiration of the specified time during which the goods are to be held in such storage, give notification to the shipper of the information specified in (1), (2), and (3) above, and maintain a record thereof as part of its record of the shipment. Failure or refusal of a carrier to notify the shipper in accordance with the foregoing shall automatically effect a continuance of carrier liability pursuant to the applicable tariff provisions with respect to S.I.T., until the end of the day following the date upon which notice is given.

NOTE: This item will take precedence over corresponding provisions of RULE 45, Storage-In-Transit.

**RULE 50**

**DEFINITION OF HOLIDAYS**

Except as otherwise specifically provided in this tariff, reference to the term "holiday" shall be the date such national or officially declared State holidays are observed.

When a holiday falls on a Saturday, the holiday will be observed on the preceding Friday. When a holiday falls on a Sunday, the holiday will be observed on the following Monday.

## GENERAL RULES AND REGULATIONS

RULE 51REMOVAL OR PLACEMENT OF PROPERTY FROM OR TO INACCESSIBLE LOCATIONS

It is the responsibility of the shipper for removal or placement of the property from or to attics, basements and other locations, and to make property available to the carrier where the location of property and goods to be shipped or delivered is (1) not accessible by a permanent stairway (does not include ladders of any type), (2) not adequately lighted, (3) does not have a flat continuous floor, and (4) does not allow a person to stand erect. If the shipper or owner requests and carrier agrees to removal or placement of property from or to such areas not readily accessible, Item 120, Labor Charges, will apply for this service.

RULE 52ATTEMPTED DELIVERY TO RESIDENCE FROM S.I.T.

Compensation to the carrier for attempted delivery to residence from storage-in-transit when failure to deliver is not the fault of the carrier, will be as follows:

1. Round trip mileage from the warehouse to residence and return.
  - a. If total mileage is 30 miles or less, Section 3, Pick-Up or Delivery Transportation Rates on Storage-In-Transit Shipments WILL APPLY.
  - b. If total mileage is greater than 30 miles, the transportation rates in Section 2 WILL APPLY.
2. Warehouse Handling: A second warehouse handling charge will apply if the shipment is again placed into storage-in-transit.

NOTE: If the shipment remains on the vehicle until delivered, this additional warehouse handling charge WILL NOT APPLY.

3. Waiting Time: The provisions of ITEM 180 WILL APPLY if carrier is required to wait at residence.

4. Storage-In-Transit: If property is again placed into storage-in-transit, storage charges will continue at the additional daily rate.

NOTE: First Day S.I.T. rate WILL NOT APPLY on shipments returned to S.I.T.

RULE 53OVER-DIMENSION PERMITS

When a shipment, or portion thereof, contains an over-dimension article which, when loaded on carrier's vehicle, requires carrier to obtain federal, state or local permits for over-width, over-height, over-length or any combination thereof, to legally transport such articles, carrier will obtain such necessary permits and advance charges for such .

Where federal, state or local laws also require the use of one or more flagman and/or one or more escort vehicles to legally transport such over-dimensions article, carrier will make arrangements for these services and advance charges for such.

All such advance charges will be supported by paid receipts and are in addition to all other applicable tariff charges.

Item 180, Waiting Time Charges, will also apply during any hour of the day, including Saturdays and Sundays, without any allowable waiting time, when carrier is prevented by law, regulations, or otherwise from performing over-the-road transportation due to the nature of the over-dimension article(s). The waiting time charge may be applied at origin, destination, or enroute and may apply more than once on a shipment.

## ◆ SECTION 3

### PICK-UP OR DELIVERY TRANSPORTATION RATES ON STORAGE-IN-TRANSIT SHIPMENTS

Applying on shipments of household goods when released to a declared valuation not exceeding 60 cents per pound per article.

#### APPLICATION

Rates are subject to the minimum weights as provided in rules herein, and both the Pick-up and Delivery rate will be based on the higher minimum weight applicable. Except for pick-up or delivery of portions of the shipment, such rates will be based on actual weight of the portion of the shipment, subject to 1,000 pounds minimum (except as provided herein).

Rates apply depending upon location of warehouse as shown below on pick-up or delivery of storage-in-transit shipments when point of pick-up or delivery and warehouse are both located within the same municipality or within a distance of thirty (30) miles or less.

For rates to apply when points are not within the same municipality or not within a distance of thirty (30) miles or less, apply rates in Section 2.

Rates in this section do not include Additional Services and Charges shown in Section 1. Rates in this section are to be applied to the actual weight of the shipment plus weight additives of **Item 270** when applicable (subject to the minimum weights as provided in rules herein). Rates are expressed in terms of dollars per shipment and in terms of dollars and cents per 100 pounds of additional weight.

Rates include loading and unloading and the actual movement or transportation of property from origin to destination, but do not include Additional Services and Charges shown in Section 1.

The rates in columns headed by a specific base weight (i.e. 1,000 pounds, 4,000 pounds, etc.) are in flat dollars per shipment for that base weight. Rates in columns headed "ADD'L CWT" are for excess weight and are in dollars and cents for each additional 100 pounds of excess shipment weight that is greater than the specific base weight of the shipment.

EXAMPLE: The charge for a shipment weighing 8,000 pounds delivered within a distance of 30 miles under Schedule A will be \$811.00.

The charge for a shipment weighing 8,358 pounds will be \$811.00 (the charge for 8,000 pounds) plus \$9.94 for each additional hundredweight greater than 8,000 pounds or an additional \$35.59 (\$9.94 times 3.58 hundredweights) for a total linehaul charge of \$846.59.

FUEL COST RECOVERY CHARGE

The following Fuel Cost Recovery Surcharge will apply as follows on shipments of household goods in use, between points in Pennsylvania, transported distances in excess of forty (40) miles.

- ( a ) The Fuel Cost Recovery Surcharge will be calculated using a "BASE PRICE PER GALLON" of \$1.267.
- ( b ) On the first Monday of each calendar month, the "CENTRAL ATLANTIC" average price per gallon of diesel fuel will be determined based on the price stated by the U. S. Department of Energy (DOE), Energy Information Administration (EIA) survey of "Retail-On-Highway Diesel Prices." This price will be obtained by calling the DOE Fuel Hot Line at 202-586-6966 or via the DOE Internet Website at [www.eia.doe.gov](http://www.eia.doe.gov).
- ( c ) If the first Monday of the calendar month is a federal holiday, the price will be determined based on the stated DOE price available on the next subsequent business day (Tuesday).
- ( d ) The DOE fuel price obtained will then become effective on the fifteenth (15th) day of the same month. The adjustment determined will apply for shipments loaded beginning on the 15th day of the month and remain in effect through the 14th day of the subsequent following month starting from the effective date of this item.

THIS PROCESS WILL CONTINUE MONTH AFTER MONTH BASED ON THE "NEW" MONTHLY FUEL COSTS.

FOR EXAMPLE

If the reported price of self-service diesel fuel determined on Monday, 10/01/2018, is \$3.447 per gallon, that amount will apply for the purpose of calculating the difference between that amount and the base price of \$1.267 per gallon for shipments loaded as of October 15, 2018 to November 14, 2018.

TO DETERMINE THE FUEL ADJUSTMENT AMOUNT TO APPLY, FIRST DETERMINE THE DIFFERENCE BETWEEN THE "BASE PRICE PER GALLON" AND THE MOST CURRENT SELF-SERVICE DIESEL FUEL PRICE PER GALLON.
