NC Lawmakers File Bill to End Taxes on Tips, Overtime and Bonus Pay

Raleigh, N.C. – Today, North Carolina Representatives Harry Warren, John Bell, Erin Paré and Allen Chesser introduced House Bill 11, “No Tax on Tips, Overtime and Bonus Pay.” The legislation eliminates state income taxes for tips and overtime while also providing a tax deduction for bonus pay up to \$2,500.

“This is a common-sense way to reward hardworking hourly employees who go above and beyond to support their families,” said Rep. Warren. **“It also incentivizes workers to take on extra shifts and helps employers fill vacant positions.”**

“Many hourly workers rely on tipped and overtime wages to pay their bills,” said Rep. Bell. **“By allowing these folks to keep more of their hard-earned money, this bill increases take-home pay, supports job growth and honors the value of hard work.”**

House Bill 11 would provide a tax deduction for the following:

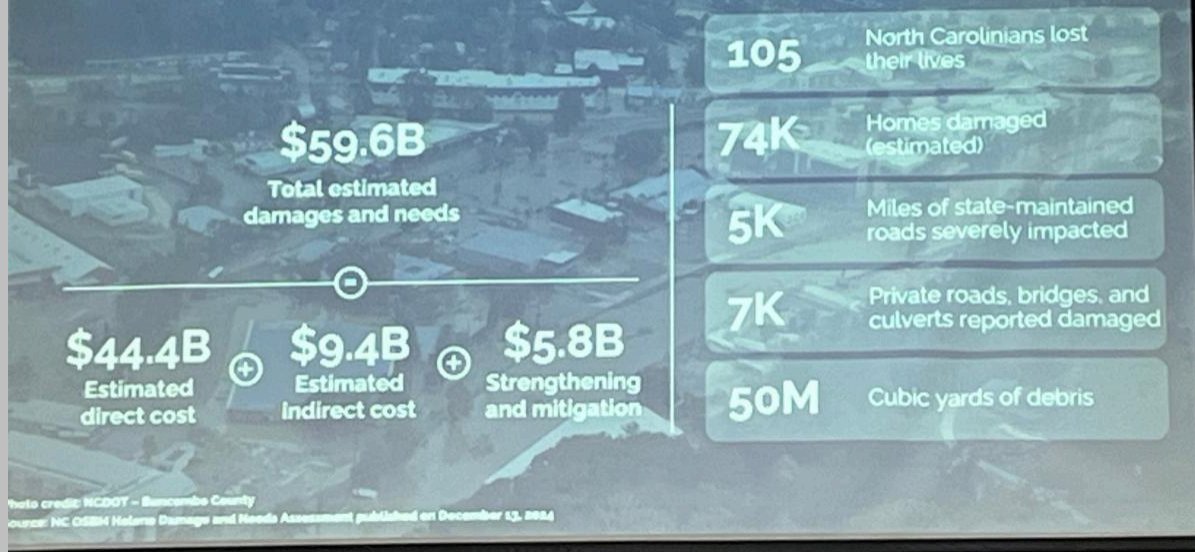
- Any amount received as overtime compensation.
- Up to \$2,500 of “bonus pay.”
- Any amount received as tips.

“I’m proud to join my colleagues Representatives Harry Warren, John Bell and Allen Chesser in introducing HB 11 which ends taxes on tips, overtime and bonus pay.” said Paré.

This week, Rep. Pare and the Select Committee on Helene Recovery met for the first time this legislative session. Lawmakers received an update on FEMA housing and Federal resources.

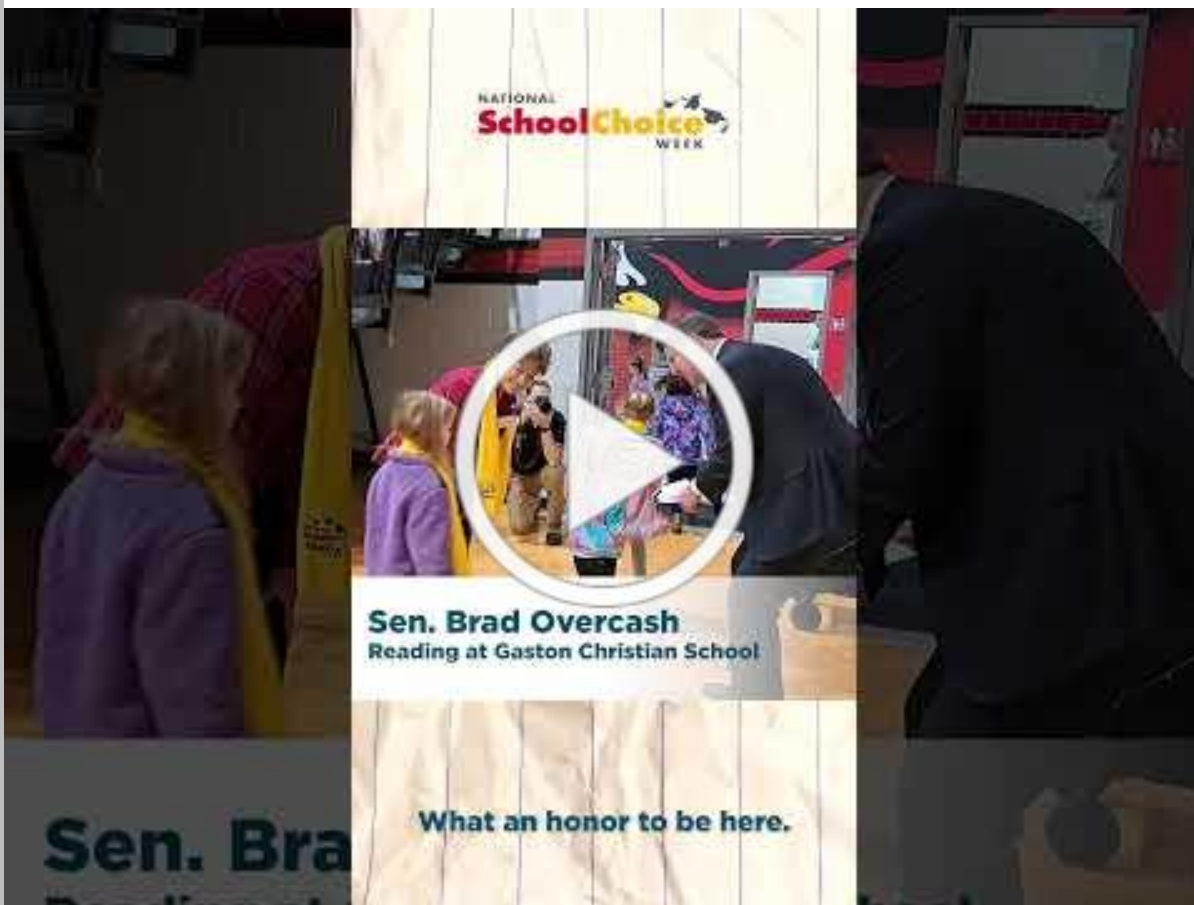

HB 14 "Gambling Losses Tax Deduction"

Bill filing opened on January 29th. One of the bills filed by Rep. Paré is [HB 14 "Gambling Losses Tax Deduction"](#).

This bill conforms NC law to federal law by providing for an itemized deduction of gambling losses capped at winnings. The bill makes a correction to NC tax law to prevent a tax environment where a person is required to pay tax on income they never received and may not have the wherewithal to pay. This bill is about ensuring a fair income tax environment in NC that is consistent with the NC constitution AND federal law. The NC constitution says the state should tax NET income, not GROSS income.

For example: If John Smith bets \$1000 and wins \$500, he didn't net any income, yet current state law requires him to pay taxes on that \$500, even though he never received it. Federal law doesn't do that, it allows John Smith to deduct the loss capped at what he won, so he isn't paying tax on income he never received. This bill aligns NC with federal law and prevents John Smith from paying a tax on income he never got and may not have the wherewithal to pay since he never received that income.

As many NC residents assume that NC state law conforms to federal law already in this area, this bill will prevent surprise tax bills and provides clarity for the taxpayer. I appreciate my fellow primary sponsors of the bill Rep. Keith Kidwell, Rep. Steve Tyson, and Rep. Matthew Winslow.

Gambling losses (IRS Code)

You may deduct gambling losses only if you itemize your deductions on [Schedule A \(Form 1040\)](#) and kept a record of your winnings and losses. The amount of losses you deduct can't be more than the amount of gambling income you reported on your return.
