# Capitol Building and Representative Paré Speaks to Students in Raleigh

North Carolina's 16 Presidential Electors met Tuesday at the State Capitol Building to officially cast votes for President-Elect Donald Trump, who won a majority of votes in North Carolina on Election Day.

On Wednesday, Rep. Paré visited with high school students at Fletcher Academy in the morning and Millbrook High School in the afternoon.

She was able to speak with AP United States Government and Politics students at Mr. Segal's class at Millbrook High School about state government. The students asked excellent questions; they were interested in learning about how state government works and the role of state legislators. The Fletcher Academy students were able to enjoy a discussion with two of the Electors and Rep. Paré about the Electoral College System.

(From article) "When I think of the value of the Electoral College, I think it's a tool to reject radicalism," said Paré. "So if you're going to be the President of the United States, and you think that you can win president by only speaking to maybe hardcore socialists or liberals or Democrats only, or urban concentrated areas that almost always vote Democrat all the time – where's the representation for other people?"

The North Carolina General Assembly overrode the Governor's veto of SB 382' "Disaster Relief-3/Budget/Various Law Changes" this month, which concluded the 2023-2024 Legislative Sessions. Both the NC House and NC Senate adjourned Sine Die on December 13th, 2024.

Here is Rep. Paré's message about SB382:

Many District 37 residents have contacted me about SB382 – many in support and many opposed. Here is my take on SB382 and why I voted YES.

The General Assembly has passed nearly \$1 billion in hurricane relief for Western North Carolina since October, not including the funding in SB382. SB382 sets aside an additional \$252M for Helene relief, from two different savings reserves: SERDF (state emergency reserve and disaster relief fund) and the Savings Reserve (otherwise called the “rainy day fund”). All Helene recovery funding is tracked through the newly formed Helene Fund.

SB382 transfers \$227M from the savings reserve to the Helene Fund, and an additional \$25M from SERDF to the Helene Fund. The \$25M SERDF funding is also appropriated to the Dept. of Agriculture in SB382 for debris removal (roads can't be built overnight, and to build a road you first need to remove debris), and another \$2M is appropriated for soil and water technical assistance. Some of the money transferred to the Helene Fund in SB382 is appropriated for certain uses and the rest is sitting in the Helene Fund to be appropriated, and there is a reason for that. It is important to note that only a fraction of the nearly \$1B that the General Assembly has already appropriated for hurricane relief in WNC has been spent. This is because it takes time to assess needs, and rebuilding infrastructure is a multi-phase process which takes time.

We must get funding out the door and in service to victims and impacted communities in Western NC (WNC) as soon as possible, but we also must be smart about not appropriating too much money too soon for certain projects that would be eligible for federal funding. If the state spends too much state money too quickly for certain projects, the state could disqualify itself from federal assistance. The cost of damages from hurricane Helene in NC is estimated to exceed \$50B, and it will take many years to fully recover. The area of damage in WNC is roughly the size of the state of Massachusetts. The state of NC is not able to cover a bill that high, without assistance from the federal government. \*Update as of 12/21/24 (News & Observer) –Congress passed a funding package that includes hurricane relief. NC is set to receive \$9B in federal aid for disaster relief.

Is this bill perfect? No. There are several provisions in this bill that if presented to me in the form of a standalone bill I would not support without a thorough vetting through the normal legislative process. This bill was presented to legislators for a vote in the form of a conference report which is not amendable. Just like every other member of the House, I was asked to vote yes or no on this conference report in its final form. I voted yes because the positive of passing this bill outweighed the parts of the bill I had reservations about.

Below is a short list of example lesser-known provisions in SB382 that are of critical immediate importance to the recovery effort in WNC. Voting “No” on this bill would mean voting “No” on these provisions, as well as the additional \$252M for Helene disaster relief.

1. School calendar flexibility for impacted school districts in Western NC;
2. \$100 million in loans for impacted local governments, among other smaller allocations;
3. Key Regulatory Relief:
  - a. Temporary Housing Solutions The legislation streamlines the placement and installation of temporary manufactured and modular dwellings and allows homeowners to connect temporary housing units to existing wastewater systems, ensuring access to essential utilities without unnecessary delays.
  - b. Faster Rebuilding and Recovery Land-disturbing activities are allowed to begin immediately as long as erosion control measures are installed, and a plan can then be submitted within 30 days. Additionally, the validity of state and local development approvals and permits has been extended to ensure projects delayed by disasters can proceed without costly renewals or reapplications.
  - c. Critical Infrastructure Improvements Temporary public water systems can be operated for up to 59 days in disaster areas and permits for wastewater management systems are valid for 12 months, with the possibility of a one-time extension. This ensures that displaced residents have access to sanitation while permanent solutions are developed.
  - d. Simplified Regulatory Framework Delaying the implementation of the updated Building Code provides local governments and builders time to adjust to new requirements without delaying reconstruction. Local governments in disaster-declared counties are prohibited from enforcing tree ordinances on private property more than 10 feet from the property boundary, removing unnecessary obstacles to clearing debris and preparing land for rebuilding. (NC Chamber)

Good news - There are a number of legislators, myself included, that will return next legislative session and revisit provisions in SB382 that appear problematic; for example, a provision involving local government downzoning. The people of NC deserve a thorough vetting of these provisions through the normal legislative process.

Lastly, I support the provision that moves the State Board of Elections (SBOE) under the State Auditor. There should be equal representation on the SBOE between Democrats and Republicans. Over the years, the Democrats and Gov. Cooper have rejected equal representation, instead insisting on a Democratic majority dominated SBOE. The North Carolina people deserve the utmost in fairness in NC elections. Moving the SBOE under the State Auditor makes logical sense – the Office of the State Auditor is charged with auditing state government; the SBOE is charged with auditing all



state elections. This is a positive step for North Carolinians that have expressed concerns with the lack of equal representation on the SBOE.

I hope that this section answered at least some of your questions regarding SB382. I will keep you updated on legislative activity as the new legislative session gets underway in January.

**Section 1.** The House Select Committee on Helene Recovery (hereinafter "Committee") is established by the Speaker of the House of Representatives pursuant to Rule 26(a) of the Rules of the House of Representatives of the 2023 General Assembly.

**Section 2.** The Committee consists of forty-seven members appointed by the Speaker of the House of Representatives. The membership of the Committee shall include legislators as specified below. Members serve at the pleasure of the Speaker of the House of Representatives. The Speaker of the House of Representatives may dissolve the Committee at any time. Vacancies are filled by the Speaker of the House of Representatives. A Chair, Vice Chair, or other member of the Committee continues to serve until a successor is appointed.
