## ICYMI - House Passes HB 87 "Cell Phone Free Education"

*House Bill 87 eliminates phones from classrooms.*

The NC House has given approval to HB 87 "Cell Phone Free Education" which requires school districts to develop a policy that severely restricts or eliminates the use of cell phones in public school classrooms. Rep. Paré voted in favor of the bill. The bill passed with strong bipartisan support 117-3.

While there are some acceptable uses for cell phones in the classroom, it is widely considered by many teachers, parents, administrators, and even students to be a major source of distraction from learning. This bill strikes the

right balance of making sure the intent to significantly restrict cell phone use in the classroom is accomplished, while also requiring individual school districts to develop the policy that is right for the district.


## Rep. Paré's Bill HB 173 "Wake County ETJ" Passes the House

Extraterritorial Jurisdiction (ETJ) = Regulation without representation.

My bill HB 173 will halt ETJ expansion in Wake County for three years.

District 37 property owners who are impacted by the Town of Garner's recent ETJ expansion plan would rather work with the County on land use and planning issues, as their property is currently located in county jurisdiction. They do not wish to be regulated by a municipality that their property is not located in and where they have no vote.

The Wake County Farm Bureau has come out in support of my bill, as well as the NC Realtors. I will continue to advocate for the passage of this bill in the Senate. It is the right think to do.



## Rep. Paré's bill HB352 "Modify Water Sewage Project Bid Req." Passes the House

HB 352 was first introduced as a local bill for just Holly Springs and Fuquay-Varina entitled "Holly Springs/Fuquay-Varina Exempt Contracts". As many bills are not in the final form when they are first introduced, neither was the first local version of HB 352. As I prepared this bill to be heard in the first committee, it became clear that the problem that I describe below is not just confined to southern Wake County; it is a problem in other areas of the state as

well.

There is a very limited number of companies able to do large water/sewer infrastructure project work in NC, (only 12, actually), not nearly enough to meet the demand for water system upgrades all across the state. As a result, it has been very hard, if not impossible for municipalities like Holly Springs and Fuquay-Varina to reach the 3 bid threshold for these projects, as required by state law. This inability to receive 3 bids requires the municipality to re-bid out for these projects. This has led to higher costs and unnecessary delays. This bill seeks to protect the taxpayer by reducing the required number of bids from 3 to 2 for water/sewer infrastructure projects for a period of 5 years.

This is a common-sense bill that adapts state law to react to the challenges of the current environment. The bill passed unanimously in the House 115-0. On to the Senate.

## Rep. Paré's bill HB156 "Increase Access for Small Employers/Insurance" Passes the Insurance Committee

This session, Rep. Paré filed HB 156 "Increase Access for Small Employers/Insurance". This bill passed the House near unanimous last session, What this bill does is reduce the employee threshold for level-funded plans from twelve to five. These health insurance plans are popular among small businesses because they provide an affordable way for small businesses to provide health insurance to their employees.

Forty-six states in the nation have level-funded plans, and only three of those states have an employee threshold above five; North Carolina is one of them and the only state in the southeast above five. This is a good bill for small business in North Carolina and to increase access to health insurance for the people of NC. An important note - the passage of this bill could help insure more people through their employer who are now receiving coverage through Medicaid expansion.

Short Title: Funds for PTSD Treatment for Police Officers. (Public)

9 officers who have been diagnosed with Posttraumatic Stress Disorder (PTSD).  
10 SECTION 2. This act becomes effective July 1, 2025.

## Rep. Paré files HB 811 "Taxpayer Transparency Act"

Here in Wake County, we have all likely experienced higher property tax bills recently. The county is not the only taxing authority that taxes our property - our local governments do as well. The purpose of this bill is to provide transparency to the tax payer about, 1. The tax rate in effect the year immediately preceding the reevaluation; 2. The revenue-neutral tax rate required by law; 3. The tax rate adopted in the year of the reevaluation; 4. The percentage increase and decrease between (2) and (3); 5. Instructions on where property owners can find government adopted budgets.

Rep. Paré, "Taxpayers deserve transparency and this bill provides that necessary transparency. Join me in supporting this bill."
