



### Introduction

Project Methodology for the engineering and build has been prepared on the basis of the Requirements Brief and information received from the operator and their team, technical site surveys of the office and studying the drawings. We also utilise the experience and knowledge which our operations and delivery teams have gained implementing multiple fit out projects for companies within similar areas. We identify the key project drivers and develop a project plan and methodology to mitigate the main risks, with particular focus on the project programme, bespoke installations and procurement period to meet the desired programme requirements

### Understanding the requirements

We fully understand your requirements for your new project, and the need to value engineer the design for it.

Working closely and collaboratively with you, Greenterra Technical Service will provide a complete service approach to the project including project planning, detailed interior architecture, engineering and technical services design development, careful management of the necessary approvals from the master developer and authorities, procurement of all necessary materials and equipment, then primarily using the Greenterra Technical Service directly employed workforce, implement the complete fit out works for a smooth handover.

### **Key Project Drivers**

Immediately upon appointment there will be a necessary intensive period of design development and client approvals in parallel with us achieving a commercial understanding and agreement. This will be quickly followed by the process of procurement for any critical long lead items, which will be vital to successfully achieving the required programme. This preconstruction period must also be used effectively to ensure that Landlord and Statutory Authority approvals are achieved smoothly and quickly.

#### Scope of Works

- The Build scope of work will include but not be limited to
- Complete schematic design and installation of all fit out works as per the approved signed off general layout plan
- Bespoke furniture and finishing's.
- MEP and Fire fighting works to suit the new layout.

#### Pre-Start Dilapidations Survey / Report and Design validation

Prior to commencement of our works on site, we will prepare a thorough written and photographic schedule of conditions and report on the condition of the building and validate the existing services to be extended as part of the works. Detailed surveys will also be undertaken to confirm the

validity of proposed design elements which may not be apparent at this stage.

### **Project office**

For the purpose of any project, a site office will be set up and maintained in the new space for the duration of all works. Project managers and site supervisors will be present, copies of all documents and procedures as well as health and safety information will be maintained there.

### Welfare area

The Welfare area is the space where we will set up breaktime facilities for our direct workforce and any necessary specialist subcontractor labour. Toilet allocations are available and will strictly be kept clean and protected by us at all times. The site entrance will display clear signage of the HSE Levels, with full PPE to be worn at all times.

### Storage space

This space will be fully protected and used to lay down stacked tools, material and goods from the time of delivery until they are utilized/ installed. This area will be discussed and agreed with Building Management. Should not enough segregated area be available we will organise space within the office unit so that some materials are delivered directly to the floor, thus reducing the requirement for landlord loading space. Other items that will form part of our site set up are as follows:

- Protection/maintenance of all CS Interiors ingress/egress material delivery and personnel routes.
- Clearly marked and maintained barrier systems where required. (e.g., material lay down areas)
- Supervision for access/egress of all operatives, additional to Building management security requirements.
- Temporary fire signage and equipment will be installed as necessary
- Temporary directional signage for public and tenanted office workers will be in place as necessary
