1 dead in Bengal residential building fire

Howrah: An elderly woman died, while 12 people were rescued from a residential building in West Bengal's Howrah district where a fire broke out on Wednesday afternoon, officials said. The body of 65-year-old Rupia Mukherjee was found inside a room of a flat in the building in Ankurhati area, Howrah. A Fire Brigade official said 12 people have been rescued from the five-story building.

The blaze, which erupted at a flat in the third floor around 1 p.m., was brought under control by five fire tenders after nearly two-and-a-half hours, he said. A forensic inquiry will be conducted to ascertain the cause of the fire, the official said.
