- Payment and billing information
- Dance class attendance and progress details
- Photography or video recordings for promotional or educational purposes (with consent)

How We Use Your Data

We use the personal data we collect for the following purposes:

- To manage your enrolment and participation in dance classes and events.
- To communicate with you about classes, performances, and other school activities.
- To process payments for tuition and related services.
- To ensure the safety and well-being of students (e.g., in case of medical emergencies).
- To comply with legal and regulatory requirements, including safeguarding and child protection.

Sharing Your Information

In order to provide the services you have requested and comply with legal obligations, some of your personal data may be shared with the following third parties:

1. Imperial Society of Teachers of Dancing (ISTD)

If you are enrolled in a qualification-based dance programme, we may need to share relevant personal information with the Imperial Society of Teachers of Dancing for the purpose of exam registration, certification, and professional development.

2. Norfolk County Council Licensing Department

We may be required to share specific personal data with the Norfolk County Council Licensing Department, for example, for licensing purposes in relation to performances, events, or safeguarding requirements.

Legal Basis for Processing Your Data
