BVRPD PATCH, LETTERHEAD, CAR(s) DECALS – discussion, proof of patch, all seemed to agree they liked the patch design, Car Wraps – Police Officers are to reach out to Signs Made Fast, Freedom, PA – quote (borough used this company in the past and will provide additional option)

PAYABLES: Discussion on what to do until the BVRPD is an entity and we receive grant money. Discussion and agreement that each municipality can pay for starter costs. Each municipality will keep receipts, records and will be deducted from the starter money that each municipality will have to pay.

TAX ID: Discussion, BVRPD will need to obtain and register for Tax ID, process normally takes a few days. Working through completing registration.

DISCUSS SAFETY RESOURCE OFFICER (SRO) – Baden Academy wants a resource officer. Discussion and finalization of costs – Standardize costs and that cost will be presented to any of the schools, academy, etc. across our boroughs. Commission/Police need to finalize costs to present – Mike Stuban, Scott Levenson, Police to validate the number.

Once number is finalized, Commission/Police need to meet with each of the schools – Freedom and Baden Academy

SOLICITOR: Discussion on potential Firms – Shannon Steel and Campbell Durans were potential. Meetings with firms to be scheduled.

CIVIL SERVICE BOARD: Discussion – a board that consists of representatives from across the borough will need to be appointed. Each town will propose two names and one alternate. The Civil Service is appointed by Commission. Commission and Civil Service will need to update Civil Service Bylaws and Rules, etc.

EMERGENCY MANAGEMENT: Nadine Padezanin asked if Emergency Management can be part of the Regionalization – Debbie Giska Rose, Mike Stuban discussed how we believe each Borough should continue to have separate Emergency Management appointees. Group consensus that it remains that way.

BREAK OUT COMMITTEES: To review to do in each committee, tactical next steps. Each committee reviewed each item and as a group defined next steps.
