<u>Pulaski:</u>

Chairman Levenson discussed a recent conversation with the Pulaski Supervisors Chairman. Pulaski will consider and reach out with their decision. If we're going forward, a meeting will be scheduled to discuss and finalize details.

- Daughtery Township:
  - Large square footage area
  - Low call volume (mentioned multiple times)
  - Their current contract good until 2025

- Estimated current contract approx.. \$223K for 2025
- o BVRPD would need to add additional officers (1 to 4)
- Assumption they could possibly want to join in the future.
